NOTIFICATION
SRINAGAR, THE 12th July 1995

SRO 158: - With a view to regulate the admission to post-graduate Degree and Diploma Courses in the Government Medical Colleges of the State, the Government hereby make the following order, namely:-

1. Short title:- This order may be called The Jammu and Kashmir Government Medical colleges(Selection of candidates for post-graduate Degree and Diploma courses) procedure Order, 1995.
2. Definitions: In this order, unless the context other wise requires:-
 - a) "Competent Authority" means the Authority constituted by the Government of Jammu and Kashmir for purposes of conducting entrance examinations and making selections for admission to various professional courses.
 - b) "Non-permanent Resident Doctor" means a doctor with MBBS Degree from any of the Universities of the Jammu and Kashmir State whose parents are not permanent residents of the State as defined in section 6 of the Constitution of Jammu and Kashmir State but are:-
 - i) The members of All India Services allotted to Jammu and Kashmir State cadre and are actually serving in this state,
 - ii) The employees of the State/Central Government or the Institutions run by the State or Central Government, physically serving in the State of J&K.
 - c) **Permanent Resident Doctors** - means a Doctor with MBBS Degree who is permanent resident of the State within the meaning of Sec.6 of constitution of J&K.
 - d) **Post graduate Degree and Diploma Courses**:- Means 3 years post graduate Degree courses and two year Postgraduate Diploma courses respectively undertaken after completing MBBS examination.
3. **Eligibility**:- A candidate shall not be eligible to apply for selection for post graduate Degree or Diploma courses unless he is a permanent resident Doctor or is a non permanent Doctor.
 - (i) Provided that only one seat in each of the State Medical Colleges of Srinagar and Jammu shall be reserved for the candidates falling under item(ii) of clause (3);
 - (ii) Provided further that the candidates to be selected are well within the merit upto which candidates falling under 3 (I) are selected
 - (iii) possesses MBBS degree or its equivalent degree recognized by the University of Kashmir or Jammu and the medical Council of India;
 - (iv) is registered with the State Medical council; and

- (v) has completed satisfactorily one year's pre-registration compulsory rotatory internship in duly recognized institutions as laid down by the University of Jammu/Kashmir for registration as a Medical Graduate.
4. **Written Test:-** (1) The Competent Authority shall conduct annually a written test for making selection of doctors for post graduate Degree and Diploma courses in different disciplines in the two Government Medical Colleges of the State on the basis of their merit and College/course option in the manner hereinafter provided. The college/course option shall, however, be subject to the availability of seats in the respective colleges/courses.
(2) The written test shall be of the MBBS standard prescribed by the University of Kashmir/Jammu, comprising two papers of 150 marks each with multiple choice questions, namely:-
- (a) Pre and para clinical subjects and
(b) Clinical subjects.
5. **Choice of Discipline:-** The Competent Authority, Entrance Examinations shall notify each time discipline-wise number of vacancies referred by the Principals of the two Medical Colleges of the State, and the candidates shall have the choice to opt for all or any such courses in order of preference. The option once exercised shall be final.
6. **Determination of merit:-** The merit of the eligible candidates shall be determined separately in each discipline on the basis of the total marks obtained in the aforesaid written test.
- In the case of candidates securing equal marks, the interse-merit shall be determined in the following manner:-
- (i) Candidates obtaining higher marks in Paper-II (Clinical);
(ii) Candidates obtaining higher marks in the qualifying examination.
(iii) Candidates who are older in age if the marks in (I) and (ii) are also equal.
7. **Preparation of the Select List:-** The Competent Authority shall prepare a final select list of candidates separately in each discipline on the basis of merit determined under clause 6. Keeping in view the preference given by the candidates in their application forms. The allocation of disciplines made by the Competent Authority shall be final
8. **Publication of the Select List.** The Competent Authority shall publish the select list prepared under clause 7 in at least two daily newspapers having wide circulation in the State of Jammu and Kashmir.
9. **Period of Joining Classes:-** The selected candidates shall join the classes in the medical college, Srinagar/Jammu, as the case may be, within a period of 20 days from the date of publication of the Select List in the newspapers, failing which the selection shall stand

cancelled and the vacancy/vacancies so caused shall be filled up from amongst the other candidates shown in the waiting list strictly in accordance with their order of merit.

10. **Waiting List**:- The competent Authority shall prepare a Waiting List in each discipline in order of merit which shall remain valid for one month from the last date of regular admission.

Explanation:

Regular Admission means the admission made within the stipulated period of 20 days from the date of publication of the select list.

11. **Rejection of Application**:- The application Form, if found incomplete in any respect or received after the prescribed date and time, shall be rejected and in that event no correspondence shall be entertained with such an applicant.

12. **Cancellation of Admisison**:- If at any stage it is detected by the Competent Authority or the Principal of the medical college concerned that any candidate has secured admission to a Post-graduate Degree or Diploma course by fraud, concealment of facts or mis-statement, the admission of the candidate shall stand cancelled and such a candidate shall also stand debarred from seeking admission to any Post-Graduate Degree and Diploma Course in future and shall also be liable to criminal proceedings.

13. **Repeal and Saying**:- The Jammu and Kashmir Government Medical Colleges(Selection of Candidates for Post-Graduate Courses) Procedure Order, 1989 issued vide notification SRO 03 dated 3rd January, 1989 as amended from time to time is hereby repealed;

Provided that such repeal shall not affect the previous operation of the order so repealed or anything duly done or suffered thereunder.
