In Continuation of Notification No. 41-BOPEE of 2018 dated 18-05-2018 the schedule for submission Online Preferences has been revised and shall now be as under:-

1. Last Date of Filling Up of Preferences : 04-06-2018
2. Last Date of Payment of Online Fee : Upto 04-06-2018

NOTE:-

1. During the above extended period, the candidates can review the preferences also if they so choose but shall have to follow the procedure as contained in Notification No. 41-BOPEE of 2018 dated 18-05-2018 (para 2).
2. Those candidates who have not locked the preferences should also do so and make necessary payment failing which they shall not be considered.
3. It is reiterated that candidates should ensure that there is no payment failure. They should verify the same from the printed Preference Form where status of payment is indicated.
4. The candidates whose result was with held and has been notified vide notification no. 46 -BOPEE of 2018 dated 29-5-2018 should follow the same procedure for filling up of the preferences as notified hereto fore.
5. The candidate should also go through notification No. 45-BOPEE of 2018 dated 28-05-2018 while filling up of the preferences.
