In furtherance to Public Notice No. 059- BOPEE of 2018 dated 28-6-2018, applications on the plain paper are invited from the candidates belonging to either of the following categories for the Central Pool MBBS seats in different Colleges outside the J&K State under Government of India, Ministry of Health & Family Welfare Quota for the year 2018-19, which should reach the office of the Board of Professional Entrance Examinations (BOPEE), Bhagat-i-Barzulla, Opposite J&K Bank, Barzulla Srinagar/BOPEE office 4th Floor, South Block, Bahu Plaza, Jammu by or before 20-08-2018 up to 04:00 P.M sharp. - Note (a).** The children of All India Service Officers posted in the State would also be eligible to participate in the said merit system.
- (b).** Selection of candidates in category (III) above shall be entirely on merit among the eligible candidates in this category.

In addition to the above, the candidates should also fulfill the following conditions:-

1. The candidate must have passed in the subjects of Physics, Chemistry, Biology/Biotechnology and English individually and must have obtained a minimum of 50% marks (40% for SC/ST) and 45% for PH candidates taken together in Physics, Chemistry, Biology/Bio-Technology at the qualifying examination (10+2) level.
2. The selection of will be made on the basis of Rank obtained in the National Eligibility cum Entrance Test (NEET) -2018 being conducted by CBSE New Delhi. As per Graduate Medical Education Regulations 1997 of Medical Council of India , it shall be necessary for the candidates to obtain minimum marks at 50 percentile at NEET 2018. However, in respect of candidates belonging to SC/ST, the minimum marks shall be at 40th percentile. In respect of candidates with locomotory disabilities of lower limbs, the minimum marks shall be at 45th percentile. The percentile shall be determined on the basis of highest marks scored in the all India Common Merit list in NEET for admission to MBBS/BDS courses.
3. The candidates should submit the Police Verification/Authentication Certificate duly counter signed by Administrative Secretary to the Government J&K Home Department.
4. Any candidate who fails to submit the said certificates within the above stipulated time shall not be considered.
5. The candidate must mention specifically the category in which he/she applies.
6. Only 4 (four) MBBS seats are available in the following Medical Colleges:-
 1. Nalanda Medical College, Patna, Bihar
 2. Govt. Medical College, Chandigarh
 3. Govt. Medical College, Miraj, Maharashtra
 4. SMS Medical College, Jaipur, Rajasthan
7. Preference for college(s) may also be indicated in the application.


Note:-

1. The seat matrix is tentative and subject to formal reference to that effect from the State Government.

3. The candidates should submit the full bio-data on the application form including Name, Parentage, DOB, and Marks in 10+2, NEET-UG Rank, Score, Category and all the necessary documents / certificates / Proof of Identity and latest photograph duly attested by a Gazetted officer.
4. The candidates, in their own interest, are advised to produce all documents in original also at the time of deposition of application form.
5. They are advised to remain in touch with the BOPEE website i.e www.jkbopee.gov.in for any update as the selected candidates shall have to join the college allotted to them at a very short notice.
