Consequent upon the shortfall received from the Government College of Education (GCOE), Canal Road, Jammu vide letter No. GCOE/J/2018/982 and the seats allotted to candidates vide Notification No. 100-BOPEE of 2018 dated 05-09-2018, the candidates figuring in the list annexed as **Annexure "A"** to this notification, have been provisionally selected for admission to B.Ed. Course 2018 in GCOE, Jammu on the basis of merit, with due regard to reservation policy for the academic year 2018. The Principal of the College shall allow the candidates to join only after verification of requisite documents in original as notified vide Notification No. 073-BOPEE of 2018 dated 23-07-2018. The candidates so selected shall report for admission in the GCOE, Jammu up to **20<sup>th</sup> September, 2018 (4:00 p.m.)**.


Further, Waiting List as per **Annexure "B"** to this Notification shall be operated upon by the Head of the Institution **w.e.f. 24<sup>th</sup> Sept. 2018 to 28<sup>th</sup> Sept. 2018 (4:00 p.m.)** in order of merit only against the shortfall, if any, due to non-joining of the candidates up to 20<sup>th</sup> of September 2018. The Institution shall submit the shortfall, if any, to the BOPEE office, Srinagar/Jammu on **28<sup>th</sup> of September up to 5:00 p.m.**

**NOTE:**

1. The Principal of the Institution shall ensure that only those candidates are admitted, whose documents are complete in all respects. The candidates found deficient of documents figuring during the verification of documents / certificates (including Marks Card), should under no circumstances be allowed admission. The Head of the Institution shall solely be responsible for any lapse in this regard.
2. Mere enlisting of any candidate in the annexed lists will not confer any right upon him/her, if found otherwise ineligible.

3. The Rank 998 (RBA), who had failed to take admission on the basis of 3<sup>rd</sup> provisional select list forwarded vide Notification No. 097-BOPEE of 2018 dated 18-08-2018 is recommended again in view of a request having been made by her for reconsideration.
