- to bring all necessary original and self-attested photocopies of documents (to be attached with the Check List Form which can be obtained from the BOPEE Office / download from the BOPEE website www.jkbopee.gov.in). Bring the result card of AIAPGET-2019 for online verification before registration.
- The seats under management quota in MD/MS Ayush have not been filled up as there is difference in fee structure between the Management Quota seats and other seats as mentioned below. These seats along with other unfilled seats in MD Ayush shall be filled up separately by the Board on 05-10-2019
