

Notification No. 99-BOPEE of 2019 Dated 04-10-2019

The Hon'ble High Court at Srinagar in WP (C) No. 2831/2019 vide its order dated 27-09-2019 has, inter alia, been pleased to extend the last date for admissions under AYUSH courses upto 15-10-2019. Further, the Ministry of AYUSH, Government of India has also extended the cut off date for admissions in AYUSH under-graduation courses upto 15th of October, 2019 vide communication No. L-14011/14/2019-EP-I dated 30-09-2019, which was on the request of various State Government and Counselling Authorities including the BOPEE. The petitioners (KTC and ASIAN) in writ petition No. 2831/2019 have issued Notification on 29-09-2019 published in local daily at their own without waiting for the Board to issue Notifications as directed by the Hon'ble High Court vide the aforementioned order.

3rd round of counselling for filling up of seats in AYUSH courses was held on 26th of September, 2019 based on the counselling list of candidates selected for admission/upgradation was notified vide Notification No. 94-BOPEE of 2019 dated 26-09-2019. The candidates were given a letter of allotment at the time of counselling to join the colleges upto 30th September, 2019. The reporting time to join the colleges/institutes by the candidates was extended upto 4th October, 2019 (4.00 p.m.).

In order to fill the vacant seats, Board has decided to conduct physical counselling for the above seats on **09-10-2019** along with the schedule notified for filling up of the seats for BPT Courses vide **Notification No. 98-BOPEE of 2019 dated 30-09-2019**. The shortfall in BPT course as on date is as under:-

The eligible and willing candidates are, therefore, advised to report to the BOPEE Office, Jammu/Srinagar for counselling and for consideration of allotment of seats in the said colleges on **09-10-2019 at 9.30 a.m. for registration and subsequent counselling**.

Note:-

- 1. The cut off score for BAMS is 134 for OM and 107 for reserved categories.
- 2. The cut off score for BPT Courses for OM is 107 and for reserved categories 86.
- 3. The unfilled seats under P&B and reserved categories, if any, shall be converted into OM in case of non availability of candidates on the same day. Therefore, the candidates from these categories shall be considered first to enable the Board to take a decision on conversion of unfilled seats, if any.
- 4. The JIAR/JCP shall be at liberty to depute a representative to the Board to participate in the counselling process as special invitee and shall also be at liberty to give publicity to the said Notice as may be deemed fit by the colleges in accordance with the orders of the Hon'ble High Court at Jammu dated 23-09-2019 in wp (C) 3186/2019 (O&M) and subject to the conditions contained in the said order. The candidates if any approaching the college for admission may also be advised to report to the BOPEE.
- 5. The fee structure of the colleges has already been notified by the Board vide Notification No. 94-BOPEE of 2019 dated 26-09-2019. For purposes of reiteration, the fee for BPT course in OM is Rs. 46000.00 (government seats) and for Management Quota seats Rs. 90000.00 in JCP. The candidates are, therefore, advised to take a decision in the matter before they appear in the counselling. However, there is no difference in fee structure in OM and Management quota in BAMS course.
- 6. Management Quota seats shall be filed up after the OM seats are over.

- 7. All candidates upto the above cut off score shall be eligible for participate in the counseling. Those allotted seats in any other college but want to take admission in the above colleges shall also be eligible to participate in the counselling for upgradation.
- 8. The candidates who are participating for the first time in the counselling and have not registered earlier shall have to produce original documents along with a set of self attested Photostat copies at the time of registration besides counselling fee of Rs.1500/-shall have to deposit in the bank for which the details shall be provided to the candidates on 09-10-2019.
- 9. Other terms and conditions shall remain the same as notified from time to time.
- 10. *There are only 15 seats under management quota on JCP, which were inadvertently shown as 20 vide Notification No. 98-BOPEE of 2019 dated 30-09, 2019.
