Subject:- **Filling up of the BPT seats in the Government/Private Colleges – physical counselling thereof.**

Reference:- Notification No. 102-BOPEE of 2019 dated 09-10-2019.

**Notification No. 107-BOPEE of 2019**

**Dated 18-10-2019**

Based on selections made vide Notification No. 102-BOPEE of 2019 dated 09-10-2019 and consequent upon receipt of shortfall from CRC, Bemina/JCP, Jammu of BPT seats, the physical round of counselling for BPT Courses in these colleges to fill the seats, which have remained vacant, shall be conducted on 23-10-2019 simultaneously in the Board Offices at Srinagar/Jammu.

Having considered the overall response of the candidates and with a view to fill up the unfilled seats, the Board, after due consideration and without compromising on the standards for admission, has now reduced the eligibility cut off NEET score to (90) from 107, which was initially 134. Therefore, following shall be eligible to participate in the counseling process:-

- (i) Candidates whose NEET Score is 90 and above.
- (ii) Candidates who were allotted seat during earlier rounds of counselling but could not join for one or the other reason.
- (iii) Those participating for the first time in the counseling and have not registered earlier shall have to produce all documents in original along with a set of self attested documents for determination of eligibility etc.
- (iv) Those who have not paid the counselling fee so far shall have to do so and deposit Rs.1500/- in the JK Bank before the commencement of the counselling.

The eligible and willing candidates shall report in the BOPEE Office, Jammu/Srinagar at 9.30 a.m. on 23-10-2019 for registration/attendance and subsequent counselling.
