**Subject: - NEET UG – 2019 counselling/admissions- filling up of the additional sanctioned seats by Ministry of Health & Family Welfare, Government of India as a consequence of 10% quota of EWS.**

Dated 21-10-2019**

In continuation of Notice No. 90-BOPEE of 2019 dated 11-09-2019 read with Notification No. 108-BOPEE of 2019 dated 21-10-2019, the unfilled seats in three Government Medical Colleges under EWS and other reserved categories shall be filled by the Board on 14<sup>th</sup> and 16<sup>th</sup> November, 2019. The Board has issued a detailed Notification No. 108-BOPEE of 2019 dated 21-10-2019 and the candidate eligible and willing to participate in the counselling process are in their own interest advised to go through the said Notice in detail. However, summary of the Notice is as under:-

- 1) Tentative date of registration of candidates willing to participate in the counselling subject to eligibility = 23-10-2019 to 31-10-2019 on all working days from 10.00 a.m. to 4.00 p.m. in BOPEE Office, Jammu/Srinagar.
- 2) Production of EWS certificates mandatory w.e.f. 01-11-2019 to 12-11-2019. The certificate has to be issued under SRO 518 of 2019 dated 02-09-2019.
- 3) Total number of seats for EWS/other categories:-
  - 84 in MBBS:-  
(EWS 42, Other categories 42, Male 21, Female 21 in each category respectively)
  - 26 in BDS:-  
EWS 13 (Male 7, Female 6)  
Other categories:- 13 (Male 7 and female 6 )  
in three Government Medical/two Dental colleges respectively.
- 4) OM candidates eligible to compete against the seats in ASCOMS/IDS only subject to availability of seat(s), if any.
- 5) No upgradation of OM candidates as no seats are available for OM candidates in Government Medical colleges.
- 6) Candidates figuring in the State Merit List issued by the Board are eligible. However, those who had not registered shall also be given an opportunity to register in case otherwise eligible.

- 7) Tentative operative seat matrix notified vide Notification No. 108-BOPEE of 2019 dated 21-10-2019.
- 8) For facilitation of the candidates the cut off score of the candidates admitted under different courses in MBBS/BDS is also given in the said Notification.
- 9) The candidates not eligible should not approach the Board un-necessarily.
- 10) The counselling will be held on 14<sup>th</sup> and 16<sup>th</sup> of November, 2019 and the seats shall be allotted on the basis of merit cum preference and the candidates have to register, mark attendance and participate in the counselling for consideration for allotment of seat.
- 11) No proxy candidate shall be allowed.
- 12) The candidates shall have to submit proof of identification also.
