Notification No. 024 -BOPEE of 2018 Dated 05-04-2018

Whereas, consequent upon declaration of MEET MDS 2018 result by the National Board of Examinations on 23-01-2018 and after online registration by the candidates, the Provisional State Merit List was notified vide Notification No. 017-BOPEE of 2018 dated 15-03-2018; and

Whereas, vide Notification No. 018-BOPEE of 2018 dated 20-03-2018 updated merit list was issued; and

Whereas, vide Public Notice No. 024-BOPEE of 2018 dated 19-03-2018 schedule for submission of online preferences was notified; and

Whereas, vide Notification No. 019-BOPEE of 2018 dated 20-03-2018 eligible and shortlisted candidates were advised to fill in online preferences for allotment of seats upto 28-03-2018, which date was further changed from time to time and last upto 31-03-2018 with a view to enabling such candidates to fill in the preferences/update the same/deposit the fee, who had failed to do so for one or the other reason; and

Whereas, after considering the preferences of the candidates for various seats, who chose to fill in the forms/participate in the process and on the basis of the merit of the candidates read with reservation rules and other orders on the subject, the Board has selected the candidates for admission to the MDS Courses in Government Dental College, Srinagar, list whereof is annexed as Annexure "A" to this Notification. The admission list is purely provisional and in case of any information submitted by the candidate(s) is proved to be false at any stage, the admission shall be liable to be cancelled along with the penalty as may be imposed by the Board in terms of SRO 158 (rule 12), which reads as under:-



"If at any stage it is detected by the Competent Authority or the Principal of the Medical College concerned that any candidate has secured admission to a Post graduate Degree or Diploma Course by fraud, concealment of facts or mis-statement, the admission of the candidate shall stand cancelled and such a candidate shall also stand debarred from seeking admission to any Post graduate Degree and Diploma Course in future and shall also be liable to criminal proceedings."

The candidates selected for admission for the courses/college shall report to the college/institution selected and produce the other documents as may be required by the College/Institution along with the following:-

- i) Matriculation Certificate
- ii) BDS Degree certificate
- iii) Internship completion certificate.(before 31st March, 2018)
- iv) BDS Marks cards
- v) NEET Result card (wherever applicable)
- vi) State Subject Certificate
- vii) DCI/State Dental Counsel Registration Certificate(should be in possession or have obtained within one month from the date of admission, failing which the admission of the candidate shall be cancelled).
- viii) Category certificate (wherever applicable)
- ix) Candidates passed BDS Degree outside country to enclose DCI clearance/recognition certificate.
- x) NOC for seeking admission in MDS Courses from the competent authority in case of in-service candidates.
- xi) Proof of Identity by way of Adhaar Card, Driving License, Passport or any other verification document of identity as may be accepted by the Institute.
- xii) Any other document(s) as may be deemed necessary by the College.

The candidates shall also submit an affidavit to the college/institution as per Annexure "B" to this Notification broadly with effect to the following:-

- 1. The information furnished by the candidate is correct and nothing has been concealed;
- 2. In case any information proves to be wrong/false, the candidate shall be personally responsible for the consequences including the cancellation of his admission and the penalty as may be imposed upon him by the Board/Institution concerned in terms of SRO 158 of 1995 read with SRO 168 of 2014;
- 3. The candidate is not pursuing any MD/MS/PG Diploma & MDS Course in any institution of the State and if pursuing outside, has obtained NOC from the concerned University/Institution.
- 4. The candidate has not taken admission in the medical colleges/institutions in the State during 2017 and has not resigned/left the course midway.
- 5. The candidate has completed rotatory internship by or before 31-03-2018 and in case the same has not been completed by the said date, the candidate shall not be eligible for admission.
- 6. Undertaking to the effect of producing all documents required for admission.
- 7. The candidate has not taken admission in any institute of the country for PG Course during admission 2018.

The candidates shall:-



- i) report to the college/institution, immediately within a period of one week from the issuance of Notification, i.e. latest by 12th of April, 2018, so that the requisite formalities are completed by such candidates;
- have to join the college/institution compulsorily and any candidate not joining the college/course against the seat so allotted shall not be eligible for subsequent rounds of admission against the vacancies which may become available due to non-joining etc in accordance with the conditions contained in the Information Brochure. Further, such candidates who stake a claim for betterment of the seat shall also have to join the Institute/course first and then stake a claim for upgradation in terms of conditions contained in Information Brochure, which shall be considered in accordance with merit-cum-preferences of the candidates and the conditions contained therein;
- have to pass a biometric test by such date in the Board Offices at Srinagar/Jammu as may be notified by the BOPEE to ascertain that only the genuine candidates, who had appeared in the NEET examination are granted admission and there is no proxy candidate seeking admission.

The college/institute shall:-

- i) keep the admission counters open for the candidates even during off days/holidays;
- ii) ensure that the candidates allotted the college/institute have completed the internship by or before 31-03-2018, and obtain necessary proof from the candidate(s) in this regard. Under no circumstances shall a candidate be allowed admission if he/she has completed internship after 31-03-2018 or fails to produce a proof in this regard;
- submit the details of the candidates who have not joined/vacant seats latest by 16-04-2018 to enable the Board to fill vacant seats between 20th to 25th April, 2018.

The selection of candidates for above admission shall, apart from the conditions included hereinabove be regulated by such conditions not mentioned herein but notified from time to time by the Board through notices/notifications, Information Brochure etc and shall form part of this Notification and those contained in terms of DCI Regulations/State rules as applicable and notified from time to time.

This also issues subject to the outcome of writ petition, if any, pending before any competent Court of Law.
