

Subject: - Admission to MD/MS/PGD courses, 2020 - Second round of

counselling (upgradation round/allotment).

Reference: - (i) Notification No. 009-BOPEE of 2020 dated 03-05-2020.

Notification No: 011-BOPEE of 2020 Dated: 14 - 05-2020

In view of some technical issues and reasons beyond its control relating to conduct of second round counseling (upgradation/allotment) through online mode, the Board has accordingly decided to conduct the second round of counseling physically for upgradation /allotment of MD/MS/PGD seats received as short fall against Notification No- 009- BOPEE 2020, dated 03-05-2020, from Government/ Private Medical Colleges/Institutions of Union Territory of J&K and the seats which remained unfilled during 1<sup>st</sup> round of online counseling for which seat matrix is uploaded as Annexure "A" and counseling schedule shall be notified separately. Utmost care shall be taken to maintain social distance and other guidelines issued by the Government in connection with Covid-19. It is therefore notified for information of the desirous/eligible candidates that the Board shall invite tentatively only 100 candidates per day as per their UT rank and the registration shall start from 09.00 a.m. to 10.30 a.m. on each day of counselling. The candidates are advised to go through the Information Brochure and seat matrix before participating in the second round of counseling (physical). The participating candidates shall report at BOPEE Office Srinagar / Jammu well in time along with Adhaar Card and NEET PG Score Card in person.

Only such candidates shall be eligible to participate in the second round of physical counselling as mentioned below:-

- i) Who have joined the course/college/institution allotted during first round of online counselling;
- ii) The candidates who did not get a seat during the first round of counselling/who did not get a seat due to choice not available/Seat not available (CNA/SNA) in the first round of online counselling;
- iii) Those who figure in the PML but did not participate during the first round of online counselling.
- iv) In case the candidates are not upgraded on the basis of fresh preferences given by them, they shall retain the seat allotted to them during first round of online counselling. However, if a candidate is upgraded as per the preferences filled in by

- him/her during the physical round of counselling, the seat allotted to him during the first online round of counselling shall be added to the seat matrix at that relevant point of time and allotted on the basis of merit cum preference and the candidate shall have no claim whatsoever on the seat held by him prior to his/her upgradation.
- v) The seat shall be allotted to the candidates who participate in the counselling at relevant point of time on the basis of merit-cum-preference. In case any candidate fails to appear in the counselling at his/her turn he/she shall lose claim on the seat available which shall be allotted to the next available candidate in order to merit. However, such a candidate who misses the counselling on his/her turn and reports at a later date/time than of his/her turn during the counselling period shall only be considered against the seat(s), which is/are available at that point of time.
- vi) Those who are participating for the first time in the counselling shall have to pay fee of Rs. 2000/- through POS machines available in the BOPEE Offices, Srinagar/Jammu on their respective date of counselling.
- vii) The candidates who have applied under NRI/HMQ in ASCOMS in pursuance of Notice No. 24-BOPEE of 2020 dated 27/04/2020 read with Notice No. 26-BOPEE of 2020 dated 02/05/2020, and Notice No. 030-BOPEE of 2020 dated 10-05-2020 shall only be eligible to compete against such seats.
- viii)The OM unfilled seats in ASCOMS, shall also be filled up during the second round of counselling (physical).

## Note:-

- (a) Rule 17 of Reservation Rules shall not apply during the upgradation / allotment round. The candidates upgraded/allotted a seat shall be required to join the college within the stipulated time as may be notified by the Board.
- (b) The candidates who do not participate in the counselling process on their respective date/day notwithstanding his/her higher merit shall subject to the conditions contained in the Information Brochure be eligible to compete for the seats as are carried forward to the next day/date of counselling. Such candidates shall have no claim on a seat which was available and allotted to a candidate during the previous day/date of counselling on the basis of his/her merit, preference and availability of seat at the time of counselling. In other words the candidates cannot stake a claim on a seat which has been allotted to the candidate next in merit on the ground that the candidate could not participate in the physical round of counselling earlier when the seat was available. Such a process, if allowed, would mean re-opening of admission/allotment process and thereby result in non-completion of admissions within the stipulated/prescribed time limit by the MCI/Hon'ble Supreme Court of India.
- (c) The candidates participating in the physical round of counselling and allotted a seat, should in their own interest not leave the Board office as there is a possibility that a seat of his/her choice, which was not available on his/her turn of counselling may become available in the process. He/She can stake a claim on such a seat immediately once the seat is displayed on the monitor of the Board, consequent upon its vacation by a candidate so that such a candidate is considered for allotment of the seat on merit cum preference

basis. The seat allotted to him/her earlier shall become vacant and added to the seat matrix. The Board shall not a responsible in case a candidate leaves the Board office and he/she fails to stake a claim on a seat as may become available as above.

- (d) The candidates should fill up the preferences carefully and take a conscious decision whether to participate in the physical second round of counseling or not.
- (e) The candidates who did not join the college on allotment of seat after second round of counselling shall not be eligible to participate in the subsequent round of counselling. Those candidates who have been upgraded during the second round shall not be eligible to participate in subsequent rounds of counseling notwithstanding his/her joining the college.
- (f) The Board reserves the right to notify such changes as may become necessary in view of any technical difficulty or the reasons beyond its control.
- (g) The candidates should carefully decide about retention of seats and resignation, if they so decide, upto prescribed date as mentioned in the Information Brochure, 2020 of MD/MS/PGD, failing which they shall be debarred from participation in the admission process for the three years/two years as the case may be in terms of SRO 48 of 2018 dated 30-01-2018 as leaving the seat mid-way or after the last date fixed for submission of resignation shall attract the provisions of the said SRO.
- (h) Board may consider filling up the seats arising due to resignation, on the dates to be notified separately to enable the Board to complete the process in a time bound manner.
- (i) The tentative seat matrix to be operated upon during the second round of counselling is annexed as Annexure "A" to this Notification and also available on website of the Board. The said seat matrix shall undergo such changes as may become necessary due to allotment of seats in the upgradation process and vacation of the seats by the candidates. It shall also include the unfilled category seats having remained vacant and notified vide Notification No. 09-BOPEE of 2020 dated 03-05-2020.
- (j) The counselling schedule shall be notified separately as and when the MCI issues necessary calendar in this regard.
- (k) The participating candidates shall have to produce proof of Identity before they are allowed to registration/participation in the counselling as no proxy shall be allowed. Impersonation, if noticed, shall be dealt with strictly in accordance with the law.

- (I) The candidates shall have to fill up the fresh preferences and those submitted during the first round of online counselling shall be deemed to have been cancelled.
- (m) Unfilled seats, if any, after conclusion of the second round of counselling shall be notified and filled up in accordance with the same procedure.
- (n) The seats if any increased under EWS quota in Government Colleges shall be either filled during the second round of counselling or separately under rules.
- (o) The candidates shall be advised not to park any vehicle around the Board Office Srinagar as it creates problems for the local residents and also for the Board management at BOPEE Office, Srinagar. The candidates are advised to park the vehicles at their own will outside the BOPEE lane on their own risk and responsibility.
- (p) Due to COVID-19, no attendant will be allowed with the candidate in the BOPEE premises Jammu / Srinagar.

The other terms and conditions shall remain the same as notified in the Information Brochure and Notifications/Notices issued in this regard from time to time.


