Whereas, the clarification provided by the Government of India, Ministry of Health & Family Welfare, New Delhi vide Letter No. 12017/12/2019-DE dated 08-05-2020 for four seats under EWS category in respect of the Government Dental College, Srinagar in the following disciplines:-

Whereas, these additional increased approved seats were not advertized by the Board at the time of conduct of first round of online counselling due to delay in providing of clarification by the Government of India; and

Whereas, amendments in the J&K Reservation Act of 2004 have been carried out vide Re-organization Act of 2019 as enacted by the Parliament, which had effect from 31-10-2019. Besides, provision for reservation for Economically Weaker Sections (EWS) has also been provided vide SRO 518of 2019 dated 02-09-2019 in the Reservation Rules of 2005, which SRO shall be operative during the year 2020-21 and vide the said SRO, the Government has also notified the procedures for issuance of certificates to the EWS by the prescribed Competent Authorities; and

Whereas, the Board advised the candidates willing to compete against the quota as may be permissible for EWS out of the increase in intake for the above college to have their certificates prepared in accordance with the law so that the additional unfilled seats are filled up during the second round of physical counselling; and

Whereas, the Board has decided to fill up additional seats accordingly and in this regard it is hereby notified as under:-

- 1. The tentative revised operative seat matrix for the additional seats for the additional seats increased in Government Dental College, Srinagar is annexed as Annexure 'A' to this Notification.
- The candidates who shall be in possession of valid EWS certificate issued by the Competent Authority as prescribed by law in pursuance of SRO 518 dated 02-09-2019 shall have to produce the same in original along with self-attested copy of the same in the BOPEE Office at Jammu / Srinagar <u>at the time of counseling i.e.</u>. <u>06-06-2020.</u> The certificates issued should bear a reference SRO 518 of 2019 dated 02-09-2019. Incomplete certificates or the certificates issued without reference of SRO 518 shall not be entertained.
- 3. Any candidate(s) who is not in a position to report physically in the Board offices is/are advised to e-mail their preference Form, with ID proof and EWS category certificate ,if any, one day before the day of counselling ie. upto 05-06-2020. The preference Form is attached with this Notification and the e-mail ID for this purpose is <u>pgbopee@gmail.com</u>. Further, such candidate(s) are directed to keep their mobile phone switched on mode during the day of his/her counselling i.e on 06-06-2020.
- 4. The Board shall conduct the counseling for filling up of the available seats under EWS and those under reserve categories etc. as a consequence of the increased capacity of the above college and such seats as may become available as a consequence of allotment/upgradation, if any, in the Board Office Jammu / Srinagar simultaneously as per the following schedule:-

- 5. The reserved category seats, if any, remaining unfilled due to non-availability of eligible reserved category candidates shall be converted into OM and allotted to the candidates belonging to OM/reserved category candidates by treating all the candidates as OM.
- 6. The seats shall be allotted to the candidates on the basis of merit cum preference on their turn.

Following shall be eligible:-

- (a) All eligible candidates under EWS who have obtained certificates under SRO 518 of 2019 dated 02-09-2019.
- (b) The distribution of the EWS seats shall be made as per the distribution made under rules.

- (c) Additional seats in the reserved categories shall be filled up as a consequence of increase in intake by allotment/upgradation of eligible category candidates.
- (d) Any seat remaining unfilled as a consequence of above in Government Dental Colleges, Srinagar/Jammu shall also be filled up through common counseling.
- (e) Rule 17 will not apply in the counseling process.

NOTE:-

- Admissions so made under EWS category shall be provisional and if the Board receives any complaint about the genuineness of EWS category certificate of any candidate(s), the Board after verifying it through proper channels and if the verification reveals that the claim of belonging to EWS is fake/false the selection will be terminated forthwith without assigning any further reasons and without prejudice to any such further action as may be necessary under the provisions of the law as applicable in the UT of Jammu and Kashmir.
- 2. In order to ensure that the admission process is completed in time bound manner and within the cutoff date, the candidates shall be required to join the college within the prescribed time limit to be notified in the allotment/ upgradation notification.
- 3. The candidates shall have to report in the BOPEE Office at 09.00 AM. for registration, attendance and subsequent counseling on 06-06-2020. No proxy shall be permitted.

The general conditions shall remain the same as notified in the Information Brochure and the Notifications and Notices issued from time to time on the subject.

This is without prejudice to the outcome of writ petition(s), if any, pending before any competent court of law.
