

In pursuance to Notification No. 014-BOPEE of 2020 dated 30-05-2020 the upgradation and allotment round of candidates of NEET MDS, 2020 was held on 06-06-2020. The counselling of the reserved category candidates was held first upto 12.30 p.m. and there was no candidate available against the SP category seat. As per Rule 9 and 10 of J&K Reservation Act, 2004 the seat of SP category was converted into OM and allotted accordingly on merit cum preference basis. The candidates so upgraded and allotted the seats as per their merit cum preference are shown in the Annexure 'A' to this Notification.

The candidates shall have to join the allotted Colleges /Institutions by or before 12-06-2020 upto 4.00 p.m. and the Heads of the Colleges/Institutions shall forward the shortfall, if any, to the Board on 12-06-2020 at 5.00 p.m.

The others terms and conditions shall remain the same as mentioned in the e-Information Brochure and Notifications/Notice issued from time to time on the subject.

This Selection/upgradation/admission notification shall be without any prejudice and subject to final outcome of the writ petition(s), pending, if any, before any competent Court of Law.


