Whereas, the Board is receiving scores of requests/proposals including telephonic calls regarding grant of extension in time of seat surrender/submission of resignations after cutoff date i.e 18-06-2020 for NEET PG 2020 candidates, who have been allotted seat(s) during first and second round of counselling on notified dates / time; and

Whereas, issue was deliberated in the Board thoroughly and due to extension in lock down notified by the Government in connection with COVID-19, as well as the time extended by Hon'ble Supreme Court of India for last date for admission to NEET PG 2020 upto 31<sup>st</sup> of July, 2020; and

Whereas, the Medical Council of India has also decided to conduct the mop up round of counselling for filling up of All India Quota seats tentatively from 2<sup>nd</sup> week of July 2020

Now, therefore, the Board has taken a holistic view on the requests/ proposals /lockdown on account of COVID-19 and the extension of cutoff date by the Hon'ble Supreme Court of India and subsequently by Medical Council of India, and has decided to provide last and final opportunity by extending the date of seat surrender/submission of resignations by the desirous admitted candidates of NEET PG 2020 (MD/MS/PGD) upto 7<sup>th</sup> July, 2020 (4.00 p.m). Therefore, the interested candidates are advised through the medium of this Notice to submit their resignations in the concerned Colleges/ Institutions till 7<sup>th</sup> July, 2020 upto 4.00 p.m. and thereafter no extension shall be granted under any circumstances whatsoever, may be the reason. The Heads of the Institutions/Colleges shall

forward the complete list of candidates who have resigned from 18-06-2020 to 7<sup>th</sup> July, 2020, to the Board at 5.00 p.m. on same day i.e on 07-07-2020 positively.
