

It is hereby notified that the Ministry of Health & Family Welfare, Government of India has lowered the percentile cut off marks for NEET PG to 30th percentile for General Category, candidates, 25th percentile for persons with disability (UR) and 20th percentile for SC/ST/OBC category candidates for the academic year 2020-21.

Consequent upon the above corresponding cut off score for eligibility is now notified as under:-

General (UR/EWS)

= 275 Score

Reserved Category (SC/ST/OSC/RBA/ALC)

= 230 Score

PWD (UR)

= 252 Score

The candidates who fall within the ambit of said revised percentile score and are willing to participate in the mop up round shall register themselves and submit the documents as **notified vide Notice No.008-BOPEE** of 2020 dated 06-03-2020 physically in Board Office Srinagar/Jammu w.e.f. 15-07-2020 to 18-07-2020 upto 2.00 p.m. and any candidate, who has not registered earlier and does not figure in the UT merit list of 2020 but wants to be considered against the unfilled seats as shown in the seat matrix already uploaded on the BOPEE website <u>www.jkbopee.gov.in</u> may also report for registration within the prescribed time schedule indicated hereinabove.

The candidates are also advised to report at BOPEE Office, Jammu/Srinagar along with original documents and also one set of Xerox copy of self-attested documents/certificates for registration purposes.

Besides, the candidates shall have to deposit a fee of Rs.2000/- (Rs. two thousands only) at the time of registration. However, the payment shall be made through cash /POS machine available in the BOPEE Office by using credit/debit card.

NOTE:-

- It is important and for information of the intending candidates that those who do not have the NEET Score Card-2020 are advised to contact the BOPEE office Jammu/Srinagar for registration purpose within the prescribed scheduled defined / elaborated here in above.
- 2. Mere registration of candidates does not confer any right to have a claim on any vacant seat(s) which as of now are to be filled up on the basis of the available candidates in the BOPEE Office and willing to opt for the seat subject to the merit of the candidates.
