#### General Conditions:- The candidates applying for NRI/HM Quota seats;

- 1. should have applied under NEET-UG-2020 and have qualified /obtained minimum score of 147: and
- should also have uploaded documents during registration process on BOPEE website in response to the Notification No. 045-BOPEE of 2020 dated 05-11-2020 read with other Notification/Notices on the subject.

#### Fee Structure:-

- The candidate applying under Hindu Minority Quota shall be required to produce a certificate from the competent authority that he/she belongs to the Hindu Minority (HM) Community.
- 4. Only Domiciles of UT of J&K /Ladakh are eligible to compete against the seats.
- The eligible candidates desirous to compete against the above seats shall submit the above documents physically in the Board office at Jammu/ Srinagar upto 10<sup>th</sup> of December, 2020 (03:00 P.M).
- The eligibility under NRI shall be subject to such other conditions as notified by the competent regulatory body Government of India / UT Government and such orders of the Hon'ble Supreme Court applicable on the subject.


