

In continuation to Notification No.058-BOPEE of 2020 dated 07.12.2020 read with Notice No.010-BOPEE of 2021 dated 19.01.2020, it is hereby notified that :-

- The candidate(s) who have joined the college allotted to them during first round of counselling shall be eligible for up-gradation/ allotment of another college/ course, if any, available at his/ her turn of counselling and in such circumstances he / she shall loose the earlier seat which shall become part of the seat matrix immediately after he/ she is up-graded to another college/ course.
- Further, it is compulsory for such eligible candidates, who have been called for counselling first time after reducing the cut off score to 30 for OM and 25 marks for all Reserved Category shall bring with them the copy of Application Form and other relevant certificates/ documents for check and verification before their participation in the counselling process and shall have to make the payment of 1000/- as counselling charges through POS machines available in the BOPEE office, Jammu/ Srinagar on the day/ date of counselling.
