
Date	Rank	Remarks.
18-02-2021	01 to 5079	All reserved category candidates including STL/STK/CDP/JKPM/SP.
19-02-2021	01 to 2000	Open Merit candidates.
20-02-2021	2001 to 5079	Open Merit candidates.

Note:-

- The reserved category seat(s), if any, remaining unfilled on 18.02.2021 due to non-availability of eligible candidates shall be converted into open merit and filled-up on 19-02-2021 and 20-02-2021 along with seats, if any, received by the Board as shortfall. However, the reserved category candidate, if any, who wish to participate in the counselling on 19.02.2021 and 20-02-2021 as an open merit can do so strictly on the basis of merit-cum-preference.
- The candidates who have been allotted BUMS / BPT seats during first round of counselling shall also be eligible to compete against BAMS seats.
- The candidates who have already registered themselves and have been allotted UT Rank, but failed to participate in the online counselling shall also be eligible to do so after deposition of requisite counselling fee of Rs.1500/- through credit card/ debit card through POS machine available at BOPEE Office, Srinagar/ Jammu before signing the attendance/ registration.
- The seats of BAMS in Jammu Institute of Ayurveda and Research (JIAR), Jammu shall also be filled during this round of counselling including Management and P&B seats.
- The seat matrix shall be uploaded on official website of the Board in due course of time.

6. The other terms and conditions shall remain the same as notified by the Board vide e. Information Brochure / Notifications/ Notices issued from time to time on the subject.


