Attention of eligible candidates who want to be considered for allocation of MBBS/BDS seats under the Central Pool Quota of the Ministry of Home Affairs, Government of India is invited towards BOPEE's Notice No. 075-BOPEE of 2021 dated 29-10-2021 vide which the eligible candidates of NEET-UG 2021 were advised to keep their documents ready for submission of the same at the time of invitation of applications. Now, the Ministry of Home Affairs vide their communication F.No.17015/69/2021-CT/II dated 26-10-2021 have asked to invite applications on prescribed format annexed as Annexure 'A' to this Notice, for allocation of MBBS/BDS seats from Central Pool for spouse and children of terrorist victims for academic year 2021-22. Briefly the eligibility is reproduced as under:-

Educational qualification:-

The candidate must have passed in the subjects of physics, chemistry, Biology/Bio-technology and English individually and have obtain a minimum of 50% marks (40% for SC/ST and 45% for PWD category candidates) taken together in physics, chemistry, biology/bio-technology at the qualifying examination as mentioned in the clause-4(2) of Regulations of Graduate Medical Education 1997.

Selection of candidates:-

The selection of candidates will be made on the basis of rank obtained in the National Eligibility-cum-Entrance Test (NEET) – 2021 being conducted by the National Testing Agency. As per Graduate Medical Education Regulations 1997, of Medical Council of India, It shall be necessary for the candidates to obtain minimum marks at 50th percentile at NEET 2021. However, In respect of candidates belonging to, SC/ST, the minimum marks shall be at 40th percentile. In respect of candidates with specified disability, the minimum marks shall be at 45th percentile. The percentile shall be determined on the basis of highest marks scored in the All India Common Merit List in National Eligibility Cum Entrance Test for admission to MBBS/BDS Courses.

Reservation:-

The Reservation Policy being followed by the UT's of J&K and Ladakh shall apply on Central Pool MBBS/BDS Seats.

The documents required to be attached are as under:-

1. Domicile Certificate of UT of J&K/ST Certificate of Leh/Kargil for the candidates belonging to UT of Ladakh.
2. NEET Score Card.
3. 10+2 marks card.
4. Date of birth certificate.
5. Category certificate, if any.

In addition the applicants shall have to submit the following documents priority wise duly authenticated by the Home Department of J&K Government for ascertaining the eligibility under victim



Priority-i Children of families where a parent or a direct member of the family has been killed in acts of terrorism or has been an innocent victim in cross-firing or in firing by armed forces in combating terrorism. Priority-ii Children of such persons who are exposed to substantive risk due to their assignment mainly relating to combating acts of terrorism, added weightage is to be given to the persons who have come in the "hit list" of terrorist organizations.	Certificate of threat perception.	DIG/CID on the basis of the report received through proper channel initiated by the SHO concerned after receiving application from the person claiming benefit of this category.	Administrative Secretary to Govt. Home Department J&K.
Priority-iii Children of such families who have migrated from Kashmir due to the current situation and have lost their means of livelihood including their business or use of their property.	Certificate of Migration, loss of property, business and livelihood.	Supporting documents for loss of property (FIR etc), Migrant certificate from the concerned Relief Commissioner.	Administrative Secretary to Govt. Home Department J&K.

The children of All India Service Officers posted in the State/UT would also be eligible to participate in the said merit system. The selection of candidate in category (iii) above should be entirely on merit among the eligible candidate in this category.

The Last date of submission of application in duplicate is 17-11-2021 upto 2.00 P.M

Further, Board does not guarantee or undertake that mere submission of applications shall confer any right to the applicant for his/her selection, which shall be done by the concerned Ministry, Government of India in accordance with the rules/procedures on the subject.

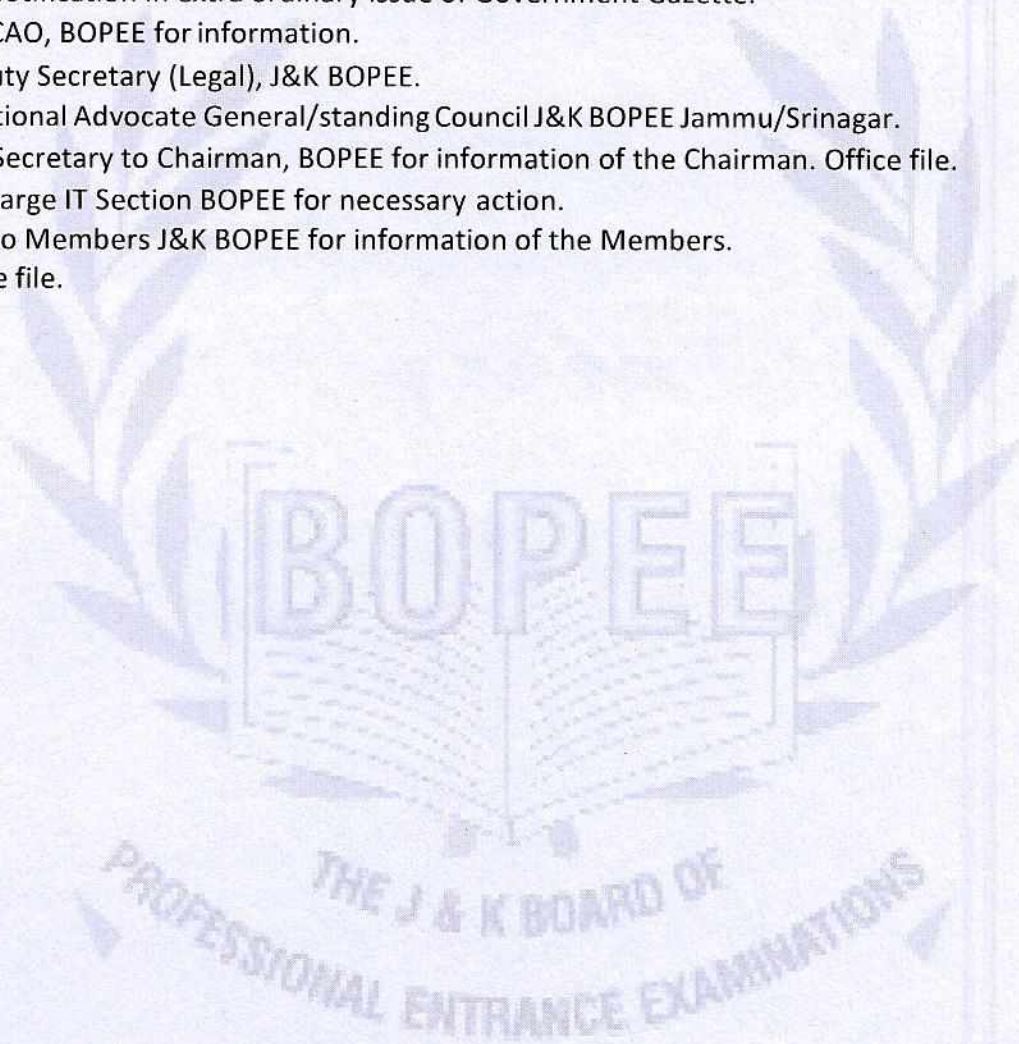
