
In view of the pending litigation before the Hon'ble High Court of J&K and consequent delay in issuance of admission list for MD/MS/PGD courses 2018, it is hereby notified as under:-

1. That after declaration of allotment list by the BOPEE as and when permitted by the Hon'ble High Court of J&K the joining time to be given to the candidates shall be reduced to bare minimum of 2 to 3 days depending upon availability of time;
2. That the candidates who have participated in the counseling are in their own interest advised to keep all relevant documents ready so that process is completed expeditiously;
3. That some candidates from Kashmir may be admitted to GMC Jammu/ASCOMS and some candidates from Jammu may be admitted in GMC Srinagar/SKIMS on the basis of their merit cum preferences, so that such candidates could move immediately to their respective allotted colleges.

The Colleges/Institutions who have already been requested to keep counters open on holidays/Sundays, shall also ensure that sufficient number of counters are opened and the time line during the day for submission of documents etc is also extended beyond normal hours of duty.

The candidates are in their own interest advised to be in constant touch with BOPEE website viz [www. Jkbopee.gov.in/jakbopee.org](http://www.Jkbopee.gov.in/jakbopee.org) for updates if any, as the admission list shall be uploaded immediately on the website of

BOPEE after conclusion of judicial proceedings and orders of the Hon'ble High Court of J&K. They should not wait for any further publication of list in any local dailies.
