The administration of the UT of Ladakh vide Notification issued vide No. M-17030/7/2021/1729-1735 dated 23-08-2021. has decided to Compulsory Government Service Policy for MBBS / BDS / Post Graduate Courses (MD/MS/PGD/MDS) so that such candidate(s) who obtain admission in various Medical / Dental Colleges / Institute both in Clinical & Non-Clinical subjects shall have to execute a compulsory Service Bond to the effect that they shall serve in the UT of Ladakh for a prescribed period immediately after the completion of the course, if the Administration requires so.

In view of above, it is hereby notified for information of all eligible candidates of UT of Ladakh to prepare the Compulsory Service Bonds on the prescribed format which is annexed as Annexure-I for PG / DNB / Diploma Courses and Annexure-II for UG Medical Courses, which are available on website of Board only along with notification issued by the Administration of Union Territory of Ladakh, Department of Health and Medical Education dated 23-08-2021. NOTIFICATION

The Administration of Union Territory of Ladakh have decided to implement Compulsory Government Service Policy for MBBS /BDS/ Post Graduate Courses so that such candidates who obtain admission in various Medical/ Dental Colleges / Inserutes of Medical Sciences by whatever name called for Graduate Degrees like MBBS & BDS & PG Degrees like MD or MS or Diplomas in various Disciplines of Medicine or Surgery (both Clinical & Non-Clinical) on the basis of Reservation Quota of the Union territory of Ladakh are made to serve in the Union territory of Ladakh for a minimum prescribed period immediately after completing their Courses so that the deficiency of Specialists & Doctors in the Union territory of Ladakh can be met in the larger public interest.

As per this notification, all candidates who apply for admission in any Medical College/ Dental College/ Institutes of Medical Sciences by whatever name called must execute a Compulsory Service Bond to serve in the Union territory of Ladakh for a prescribed period immediately after the completion of the course, if the Administration requires so. The bond has to be executed and submitted in original in the office of Director Health Services, Union Territory of Ladakh.

It is accordingly informed to all the aspirants for the aforementioned UG & PG Courses that the following Clauses regarding execution of the Bond before admission to Medical Colleges/Dental Colleges/ Institutes of Medical Sciences by whatever name called, shall come into force from the academic session 2021 and onwards as under:

Clause -1. It is hereby stipulated that the candidates of the Union Territory of Ladakh availing the reservation benefit of Scheduled Tribe Quota / UT of Ladakh Quota / Any other Quota seats shall have to execute a Service Bond in favour of the Administration of Union Territory of Ladakh stating that he/she shall serve under Administration of Union Territory of Ladakh for a period of 03 (three) years immediately after successful completion of PG Degree Courses & 02 (two) years immediately after successful completion of PG Diploma Courses and Dental Speciality Courses.

A. PG Service Bond for Post Graduate Degree / DNB / Diploma Courses:

Clause - 2. In the event of failure to serve the stipulated period under the Administration of Union Territory of Ladakh as per Bond, he/she has to pay to the Administration of Union Territory of Ladakh as under Clause 1 & 2, an amount of Rs. 50,0000/- (Rupees Fifty Lakh only) for Clinical Subjects Courses (General Medicine, General Surgery, Orthopaedics, Otorhinolaryngology (ENT), Obstetrics & Gynaecology, Anaesthesiology, Paediatrics, Ophthalmology, Psychiatry, Respiratory Medicine, Radio Diagnosis, Dermatology, Radiotherapy, etc. and Rs 45,00000/-

PROVIDED further that the Bounden and the Sureties do hereby agree that if the Bounden discontinues the study or after completion of the PG (MD/MS) Course of study to which he /she was selected, fails to serve the Administration of Union Territory of Ladakh for a period of 3 (Three) / 2 Two Years, it may be construed as professional misconduct and the fact reported to the National Medical Commission / Indian Dental Council or the Medical Council of State / Union Territory concerned for suitable action including cancellation of registration by the Council.

PROVIDED further that the bounden and the sureties do hereby agree that all sums found due to the Administration of Union Territory of Ladakh under or by virtue of this bond shall be recovered jointly and severally from them and their properties movable and immovable, as if such dues were arrears of land revenue under the provisions of Revenue Recovery Act for the time being in force or in such other manner as the Administration of Union Territory of Ladakh may deem fit.

Provided further that it is not necessary for the Administration of Union Territory of Ladakh to sue the bond holder before taking action on the surety, under this bond and the liabilities of the sureties is co-extensive with that of the Bounden and shall not be affected by the Administration of Union Territory of Ladakh giving time or any other indigence to the bounden or by the Administration of Union Territory of Ladakh varying of the terms and conditions herein contained.

(Rupees Forty Five Lakh only) for Medical PG Diploma Courses & for Post Graduate /DNB Pre & Para Clinical Subjects Courses (Anatomy, Physiology, Biochemistry, Pharmacology, Pathology, Microbiology, Forensic Medicine & Toxicology, Community Medicine etc.) and Rs. 35,00000/- (Rupees Thirty Five Lakh only) for Dental Post-Graduation Courses.

Clause- 3. In the event of failure of the candidate to complete the PG / DNB/ Diploma Course obtained under Reservation Quota by the candidate, he/she will have pay half of the Bond amount to Administration of the UT of Ladakh.

B. UG Service Bond for Under Graduate Degree (MBBS/ BDS):

Clause-4. All Candidates of Under Graduate Courses (MBBS/BDS) selected under Scheduled Tribe Quota / UT of Ladakh Quota / Any other Quota seats outside the Union Territory of Ladakh shall have to execute a Service Bond in favour of the Administration of Union Territory of Ladakh stating that he/she shall serve under Administration of Union Territory of Ladakh for a period of 05 (five) years in case of MBBS Courses and 3 Years in Case of BDS Courses immediately after successful completion of course failing which he/she will have to pay an amount of Rs. 50,00000/- (Rupees Fifty Lakh only) lakh in case of MBBS & Rs 30,00000/- (Rupees Thirty Lakh only) in case of BDS Course to the Administration of Union Territory of Ladakh.

Clause-5. In the event of failure of the candidate to complete the MBBS/ BDS Degree Course obtained under Reservation Quota by the candidate, he/she will have to pay half of the Bond amount to Administration of the UT of Ladakh.

Clause-6. The Candidate is bound to formally inform the Administration of the Union territory of Ladakh regarding his successful completion of the Course immediately after it is completed. The Service Bond obligation will not apply to a candidate if his / her appointment (in either the National Health Mission or the Health Dept; on temporary or quasi permanent basis) is not made by the Administration of Union Territory of Ladakh within a period of 10 Months from the date of communication to the Administration regarding his/her successful completion of the Course & his / her eligibility for service and the clause is applicable in all the above UG & PG Service Bond Clauses.

Clause-7. Any violation of the terms and conditions of the Bond shall invite stern disciplinary action as per the regulation 8.2 under chapter 8 of the Indian Medical Council (Professional Conduct, Etiquette and Ethics) Regulation 2002 & Regulations of Indian Dental Council Regulations, as are applicable. The details of such candidates will be reported to the National Medical Commission of India / Dental Council of India for appropriate action.

Clause-8. Any outstanding amount payable to the Administration of Union Territory of Ladakh from the applicant shall be recovered from him/her as arrears of land revenue.
