The Health & Medical Education Department UT of J&K vide letter No. ME-Gztd/52/2022 (e-office) dated 17-02-2022 has forwarded the communication No. No.U.14014/05/2021-ME-II(FTS No.80118532) dated 03.02.2022 of Government of India, Ministry of Health & Family Welfare (Department of Family Welfare), New Delhi regarding allocation of 4 (four) seats to the UT of Jammu & Kashmir from central pool for MBBS/BDS, for the session2021-22 in the following Medical Colleges:-

1.	Nalanda Medical College, Patna, Bihar	=01 seat of MBBS
2.	Govt. Medical College, Chandigarh	=01 seat of MBBS
3.	Lady Hardinge Medical College, New Delhi	=01 seat of MBBS
4.	SMS Medical College, Jaipur, Rajesthan	=01 seat of MBBS

In order to complete the nomination process by the Government, the Board has decided to invite applications on plain paper from the eligible NEET UG-2021 qualified candidates upto 25.02.2022 (2.00 PM), which shall be forwarded to the concerned quarters for further necessary action as may be deemed appropriate. The brief of the guidelines is as under:-

The selection of candidates in category III above should be entirely on merit among the eligible candidates in this category.

In addition of the above mentioned categories, the children of ALL India Service Officers posted in the UT of J&K would also be eligible to participate in the said merit system.

- 1. Date of Birth Certificate (Matriculation).
- 2. 10 + 2 Marks Card.
- 3. NEET UG-2021 Score Card (as per qualifying marks for NEET UG-2021).
- 4. Domicile Certificate issued by the Competent Authority.
- Reserved Category Certificate, if any; (Reservation as applicable to J&K).
- 6. ID Proof
- 7. Two latest Pass port size coloured photographs with white back ground.
- Preference of Colleges (Lady Hardinge Medical College, New Delhi is Women College).
- Certificate/ documents from Competent Authorities as detailed in the above table.

The last date for submission of applications with full details shall be upto 25.02.2022 (2.00 PM), failing which no application shall be entertained under any circumstances. The candidates who have earlier submitted their documents against the Notice No.002-BOPEE of 2022 dated 15-01-2022 under category II & III above shall not be required to resubmit their documents again but are advised to submit the application(s)



Note: Mere submission of documents/ applications by the candidates shall not confer any right to claim the seat, which shall be decided by the appropriate authorities of the Government in accordance with the merit/ eligibility criteria prescribed by the concerned authorities.
