- 2. 10+2 Marks Card.
- 3. NEET-UG 2022 Score Card (as per qualifying marks for NEET-2022)
- 4. Domicile Certificate issued by the Competent Authority.
- 5. Reserved Category Certificate, if any (Reservation as applicable to J&K).
- 6. ID Proof.
- 7. Two Passport Size Photographs.
- 8. Preference of Colleges (Lady Hardinge Medical College New Delhi is meant for only females).
- 9. Certificates/ Documents from the Competent Authorities as detailed in the above table.

The last date for submission of applications with full details/ documents shall be upto 18.11.2022 (till.2:00pm), no application shall be entertained after the cutoff date

1. Mere submission of documents/applications by the candidates shall not confer any right on the candidate to claim the seat, which shall be decided by the appropriate authorities of the Government in accordance with the merit/eligibility criteria prescribed by the concerned authorities.
