**Subject: Conduct of Mop up (upgradation/allotment) 3<sup>rd</sup> Round of Physical Counselling for Admission to AYUSH (BAMS/BUMS/BPT) Courses- 2022: Registration of candidates after lowering of Cut-off score for BPT-Course only thereof.**

## **Notification No. 007-BOPEE of 2023**

**Dated 23-01-2023**

Pursuant to Notification No. 005-BOPEE of 2022 dated 11.01.2022, the Board conducted 2<sup>nd</sup> Round of Physical Counselling on 9<sup>th</sup> & 10<sup>th</sup> of January, 2023 for BAMS/BUMS/BPT Courses-2022. The Board has received shortfall of seats from the Government/Private Colleges / Institutions due to non-joining of candidates, which shall be filled up including the seats which have remained unfilled after conclusion of Second Round of counselling. It is hereby notified that the Board shall conduct 3<sup>rd</sup> Round of Physical Counselling (Mop-up Round) on **27<sup>th</sup> & 28<sup>th</sup> of January, 2023** for filling up of these vacant seats of AYUSH (BAMS/BUMS/BPT) Courses - 2022 as per the following schedule: -

The candidates who are interested to participate in the Mop-up (3<sup>rd</sup> Round) of Physical Counselling are advised to report at J&K BOPEE offices Srinagar/Jammu between 09:00 a.m. to 10:00 a.m. on their respective dates of counselling for registration and fulfillment of other counselling related formalities.

### **Note - I**

Pursuant to the Short fall conveyed by Composite Regional Centre, Bemina, Srinagar (CRC) and Jammu College of Physiotherapy (JCP) vide their letters No. CRC/Sgr/Acad/4000/22/605 dated 20.01.2023 and No. JCP/88/24 dated 20.01.2023 respectively in respect of Notification No. 005-BOPEE of 2022 dated 11.01.2023 where under the Board have filled up all the seats, but the said Colleges / Institutions have reported huge Short fall again due to non-joining of the candidates which is given hereunder: -

Since there is no Regulatory Body for Bachelor of Physiotherapy (BPT) Course in Government of India / UT of J&K, but the Degrees to the candidates are being issued by the University of Jammu and University of Kashmir respectively after completion of the course successfully and in order to fill up maximum number of BPT seats in these Institutions, it is accordingly notified that the Board has decided to reduce the cut-off score for BPT-Course as under: -

Any candidate(s) who has / have not registered earlier and is /are now falling under the consideration zone due to lowering of cut-off score and is / are interested / willing for admission to BPT Course only in these Colleges / Institutions may also report at BOPEE offices Srinagar/Jammu on **27th and 28th of January, 2023** (till 3.00 pm) along with the following original documents with one set of Xerox copy duly self-attested for the purpose of completion of registration and other Counselling related formalities:-

1. NEET-UG Score Card 2022;
2. 10+2 Marks Card;
3. Date of Birth Certificate (Matriculation);
4. Domicile Certificate of UT of J&K (ST Category Certificate in respect of candidates belonging to the UT of Ladakh);
5. Category Certificate, if any, for Government Colleges only.

Further, all the newly registered candidates shall have to deposit the Counselling Fee of Rs. 1000/- only to be paid through POS machine available in BOPEE offices Srinagar/Jammu at the time of registration, if not paid earlier.

**The following candidates shall be eligible to participate in the Mop-up Round of Physical Counselling**

1. Candidates who have not been allotted any seat during the 1st or 2<sup>nd</sup> Round of Counselling shall be eligible to participate in the Mop-up Round of Counselling.

2. Candidates who have been allotted a seat during 1<sup>st</sup> Round of Online Counselling and have joined the college but have not been upgraded during the 2<sup>nd</sup> Round of Physical Counselling.
3. Candidates who have been allotted seat during the 2<sup>nd</sup> Round of Physical Counselling and have joined the College/Institution and wish to participate in the Mop-up Round for the purpose of upgradation.
4. Candidates who have been allotted a seat during 1<sup>st</sup> Round of Counselling but have not joined the College / Institute during 1<sup>st</sup> round are also eligible to participate in mop-up round.
5. The Reserved Category candidate, who may not get a seat in his /her category, shall be eligible to participate in the Counselling as an OM candidate as per his/her merit position on day/date mentioned above in table.
6. The candidates whose names and Ranks are available in the Merit List Notified by the Board vide Notification No. 104-BOPEE of 2022 dated 15.12.2022 but have not participated in the 1<sup>st</sup> and 2<sup>nd</sup> Round of Counselling shall be eligible to participate in this Round of Counselling. However, he/she shall have to deposit the Counselling fee of Rs.1000/- only through POS machine available at BOPEE offices Srinagar/Jammu.

**The following candidates shall not be eligible to participate in the Mop-up Round of Physical Counselling**

1. The candidate(s) who have been upgraded during the 2<sup>nd</sup> Round of Physical Counselling shall not be eligible to participate in the Mop-up Round.
2. The candidates who have already resigned against the seats allotted to them during first / second Rounds of Counselling shall not be eligible to participate in the Mop-up Round of Counselling.

**Note - II:**

1. The candidate(s) who will be allotted seat(s) during the Mop-up Round of Counselling shall have to necessarily join the College/Institution upto to the last date to be fixed by the Board.
2. In terms of Section 9(2) of J&K Reservation Act 2004, if any seat(s) under Reserved Category(s) shall remain unfilled due to non-availability of eligible candidates in any Reserved Category on 27.01.2023, those seats shall be converted into Open Merit immediately after conclusion of the Counselling and shall be allotted to the candidates as per merit.
3. The candidates shall note that the Counselling process for any particular category shall be closed immediately after the seats are fully exhausted.

The Seat matrix shall be uploaded on the official website of the Board ([www.jkbopee.gov.in](http://www.jkbopee.gov.in)) for information of the candidates before Counselling.

The other terms and conditions shall remain the same as contained in the e-information Brochure, Notifications/ Notices issued by the Board from time to time in this regards.
