Subject: **Conduct of Mop Up Round (upgradation/ allotment) of (Physical) counselling for admission to NEET MDS Courses 2023 in various Government Dental colleges of UT of J&K.**

## Notification No. 092-BOPEE of 2023 Dated 13-10- 2023

In pursuant to Notice No. 030-BOPEE of 2023 dated 27.09.2023 read with Notification No. 087-BOPEE of 2023 dated 25.09.2023, after lowering the cut by National Board of Examination (NBE) New Delhi, the updated new rank wise merit list is annexed as Annexure-A to this Notification, therefore, the Board has decided to conduct Mop Up Round of counselling on 15.10.2023 as per the following schedule:

It is further notified for information of all the concerned candidates that the upgradation/allotment of seats during the Mop Up Round of Counseling shall be purely on provisional basis and shall not confer any preferential right upon the selected candidates and shall be subject to the outcome of writ petition, if any, subjudice in any competent court of law on the subject.

1. The seats available for MDS course-2023 for Mop Up Round of counselling are as:

The Board shall first call the category candidates whose seats are available during Mop Up Round of Counselling Process and if the candidate(s) under that category are not available, then the same seat(s) shall be converted into OM as provided under Section 09 (2) of J&K Reservation Act, 2004 and shall be allotted on the basis of merit cum preferences.

**Note -I:**

The following procedure shall be followed during the Mop Up Upgradation/Allotment Round of Physical Counseling.

1. The eligible and willing candidates have to report at the BOPEE offices Jammu / Srinagar for Registration/Attendance & fulfillment of other formalities, from **8.30 am to 9.30 am** on the day/date of counseling for MDS Courses.
2. It is enjoined upon all the eligible candidates that they shall visit/ attend counseling only after checking the Seat Matrix available on the official website of the Board.
3. Those candidate(s) who have been allotted seat(s) during the Second Round of Counseling and have joined against the said seat/College, if, interested for upgradation are eligible to participate in the Mop Up Round of Physical Counseling with the condition that he/she shall have to produce his/her fee deposition receipt of the concerned allotted College at the time of Registration/Attendance on his/her day/date of counseling.
4. The Candidate(s) who have not been allotted any seat during the First or Second Round of Counseling are also eligible to attend the Mop Up Round of physical counseling for allotment of seats in MDS Courses-2023 on their respective day / date of counseling.
5. The candidates whose names are figuring in the Provisional UT Merit List annexed to the Notification No. 044 -BOPEE of 2023 dated 25-07-2023, but have failed to participate in the First Round of online counselling or in Second Round of counselling due to one or the other reason shall also be eligible to participate in the counselling subject to the condition that they shall have to deposit counseling fee of Rs.2000/ physically, through POS Machines kept available at the BOPEE offices Jammu/Srinagar on their day/date of counseling. Further the candidates who have become now eligible after reducing the qualifying percentiles by Ministry of Health and Family Welfare, GOI, New Delhi dated 21.09.2023 shall also be eligible to participate in the counselling subject to the condition that their names are figuring in Annexure-A to this Notification with the condition that they shall have to deposit counseling fee of Rs.2000/ physically, through POS Machines kept available at the BOPEE offices Jammu/Srinagar on their day/date of counseling.
6. The candidate(s) who have been allotted Seat(s) during the Second Round of counseling, but have failed to join or have resigned against the said allotted seat/College, he/she shall not be eligible to participate in the Mop Up Round of counseling.
7. The candidate(s) who have been upgraded during the Second Round of counseling, shall not be eligible to participate in the Mop Up Round of counseling.
8. The Board reserves the right to notify such changes as may become necessary in view of any technical difficulty or the reasons beyond its control.

**Note -II:**

The Seat Matrix for Mop Up Round of counselling which is also annexed as Annexure-B to this Notification and shall be uploaded on website of the Board for information of the candidates.

The other Terms and Conditions shall, however, remain the same as notified by the Board in the e-Information Brochure and Notifications/Notices issued from time to time in this regard.
