## Note-I:

The following procedure shall be followed during conduct of Special Stray Vacancy Round of physical counselling.

- 1. It is enjoined upon all the eligible candidates that they shall visit/attend counselling only after checking the Seat Matrix available on the official website of the Board.
- 2. As notified by MCC in the notice dated 15.11.2023, the candidates who are not holding any seat either in All India Quota (AIQ) or State Quota are eligible to

- participate in Special Stray Vacancy Round. However, candidates who did not join their seats allotted through MCC Round 3 on wards are "Not Eligible" to participate.
- 3. It has also been notified by the MCC that the Special Stray Vacancy Round is not an upgradation round. Joined candidates of earlier rounds will not be given chance of upgradation.
- 4. The candidates who have not been allotted any seat or remained absent during 1<sup>st</sup>, 2<sup>nd</sup> / Mop up Round of counselling shall be eligible to participate in this round of counselling.
- 5. The candidates who are participating for the first time in the counselling shall have to pay non-refundable counselling fee of Rs. 2000/- physically, through POS machines kept available at BOPEE offices Jammu/Srinagar on the day of counselling.
- 6. The Board reserves the right to notify such changes as may become necessary in view of any technical difficulty or the reason beyond its control.
- 7. The seat matrix for Special Stray Vacancy Round shall be uploaded on the website of the Board before the date/day of counselling.

The other terms and conditions shall remain the same as notified by the MCC/JKBOPEE from time to time in this regard.
