Subject: Cancellation of Provisional admission of Ms. Farwah Fatima D/O Manzoor Hussain R/O Waterwani Budgam, provisionally selected for undergoing MBBS Course-2022 under PwD category in the SKIMS Medical College Bemina Srinagar.

Whereas, consequent upon the declaration of NEET UG 2022 result, by the National Test Agency (NTA) on 17.07.2022, and subsequent Notification / Notices issued by the Board with regard to Registration / verification of documents, filling up of online preferences etc. and after due application of reservation rules (as amended from time to time), the list of provisionally selected candidates for undergoing MBBS/BDS courses 2022 in various Government / Private Medical / Dental Colleges of the UT of J&K was notified vide Notification No. 084-BOPEE of 2022, dated: 16.11.2022; and

Whereas, by virtue of the above mentioned Notification No. 084-BOPEE of 2022 dated: 16.11.2022, amongst others, one Ms.Farwah Fatima D/O Manzoor Hussain Wani R/O Waterwani, Budgam, NEET UG Roll No. 2505010123, UT Rank 1802, was provisionally selected for admission to MBBS course in SKIMS Srinagar under RBA (PwD) category; and

Whereas, the above mentioned Notification No. 084-BOPEE of 2022 dated 16.11.2022, inter-alia stipulated as under:

- That it shall be sole responsibility of the College concerned to ensure proper check and verification of documents before the candidate(s) is allowed for admission strictly as per NMC (MCI)/DCI guidelines.
- That the admission of the candidates is purely provisional and in case any information furnished by any candidate proves to be false / fabricated, and action as warranted under law shall be initiated against such candidates.
- That it is implored upon the management of the concerned Colleges to ensure the veracity of documents, particularly the Category Certificates wherever the admission is to be granted in lieu of a Reserved Category. So far as the Persons with Disability are concerned, if selected under Open Merit or against a Reserved Category, it shall be ensured that his/her PwD

Certificate / eligibility is in conformity with Rights of Persons with Disabilities Act, 2016 and wherever required shall refer the matter to the concerned Medical Board i.e. Government Medical College Jammu/Srinagar to assess the disability of such candidate(s) and make recommendations that the candidates, if any, does not fulfill benchmarks of eligibility, he / she shall not be admitted to the course / college and the matter shall be reported to the Board for further course of action; and

Whereas, accordingly, in order to ascertain the veracity of the PwD certificate issued by the Medical Authority Budgam in favour of above said Ms. Farwah Fatima, under certificate No. JK0210420000022348 dated 21.08.2022, she was referred by the SKIMS Medical College Bemina to the Medical Board constituted for this purpose; and

Whereas, the Head of the Department, ENT SKIMS Medical College vide No. SKIMS/MCH/ENT/23/181 dated 03.04.2023 informed that at the relevant time, the ENT Department did not have an audiologist and the authenticity of the Pure Tune Audio Gram provided cannot be verified and recommended that the alternate approach may be adopted; and

Whereas, soon thereafter on 12.04.2023, the candidate (Ms. Farwah Fatima) voluntarily submitted an application pleading therein that her admission may be cancelled, as she is not able to bear the pressure of the studies; and

Whereas, subsequently on 17.04.2023, she returned back with the request to the college Authorities that she may be allowed to continue her studies in view of insistence and motivation of her parents and teachers and therefore desired to withdraw her application for cancellation of admission; and

Whereas, in the meanwhile, vide No. SKIMS/MC/Acad/1427-29 dated: 24.04.2023, the case was referred to the HOD, ENT Government Medical College, Srinagar for examination and assessment, however instead of cooperating and presenting herself for examination, Ms.Farwah Fatima played hide and seek and once again submitted an application on 26.04.2023 along-with affidavit attested by the First Class Magistrate, Budgam, seeking cancellation of her admission citing the reason of tough nature of the studies of Medical Education, health issues and some domestic hurdles; and

Whereas, on 06.05.2023, Ms. Farwah Fatima once again withdrew her application for cancellation of her admission and the case was therefore referred to Dean Medical Faculty (SKIMS) for decision, and said office conveyed as under:

"Decision may be taken at the College level (Compassionate one)"; and

Whereas, in the meantime, the Head of Department, ENT Government Medical College Srinagar vide letter No. HOD/ENT/3036 dated 23.05.2023 conveyed to the SKIMS Medical College Bemina Srinagar that the candidate reported to the OPD on 18.05.2023 and was accordingly examined and asked to report back for investigation of Pure Tune Audio Gram but she did not report back and thus, final opportunity is given to her, to present herself

before the Department of ENT, GMC Srinagar within a period of 10 days for the aforesaid investigation; and

Whereas, Ms .Farwah Fatima yet again submitted an application for cancellation of her admission on 29.05.2023 and the College Administration submitted the case to the Dean Medical Faculty, SKIMS Soura Srinagar on 05.06.2023 for cancellation of her admission and the decision whereof was taken by Dean Medical Faculty, SKIMS, Soura, Srinagar on 08.06.2023 and communicated to the college on 13.06.2023, which read (verbatim) as under;

"Because she is not co-operating with verification of her reservation certificates, she may be removed from the rolls of MBBS".

Whereas, also in the meanwhile, Head of Department, ENT Government Medical College Srinagar, vide communication **No.** HOD/ENT/3060 dated 29.05.2023, furnished findings/ recommendations as under;

"The Clinical Examination done by the Doctor and Pure Tune Audio Gram done by our Audiologist reveal that patients hearing is within normal limits".

Whereas, the Principal SKIMS Medical College Bemina Srinagar vide letter No. SKIMS–MC/PS/2023/993-94 dated 25.09.2023 intimated that the clinical examination and Pure Tune Audiogram have clearly established that the Patient's hearing is within normal limits. Furthermore, Registrar Academics has also verbally communicated that the candidate is no longer attending the classes;

Whereas, Ms. Farwah Fastima has not only produced false/fabricated information but has also concealed material information from the Board to mislead;

Now, therefore, in view of the above, candidature of Ms. Farwah Fatima D/o Manzoor Hussain Wani R/o Waterwani, Budgam in the provisional merit list (PML), notified vide Notification No. 072-BOPEE of 2022 dated 26.10.2022 read with Notification No. 074-BOPEE of 2022 dated 04.11.2022 and in the provisional selection list, notified vide Notification No. 084-BOPEE of 2022 dated 16.11.2022, issued by the JK BOPEE, is hereby cancelled and shall and shall always be deemed to be so *ab-initio*.
