Subject: Provisional Selection of the NEET UG candidates for admission to the MBBS/BDS Courses for the Academic Session 2023-24: Cancellation of provisional admission of **Ms. Safiya Jan** D/o Jan Mohammad R/o Tarabal Nawakadal Srinagar for undergoing MBBS course-2023 under PwD category in the SKIMS Srinagar thereof.

1. Whereas, in order to conduct uniform entrance examination for admissions in all medical education institutions for under-graduate and post-graduate levels, the Medical Council of India (MCI), now NMC, in the year 2010, notified a single Entrance Examination for the candidates, namely, the National Eligibility-cum- Entrance Test (NEET) to be conducted by the National Testing Agency (NTA);
2. Whereas, vide Public Notice dated 06.03.2023 issued by National Testing Agency, applications were invited from the candidates for appearing in the NEET, which was conducted on 07.05.2023. After declaration of the NEET-UG result by the National Testing Agency (NTA), New Delhi on 30.06.2023, the Ministry of Health and Family Welfare, Government of India provided the result of the candidates belonging to the UT of J&K/Ladakh, who had appeared in the National Eligibility Entrance Test (NEET) to the JKBOPEE; and
3. Whereas vide Notification No.035-BOPEE of 2023 dated 06.07.2023 JKBOPEE notified the Roll Number-wise list of the candidates of UT of

J&K/Ladakh who have appeared in NEET-UG 2023 conducted by the National Testing Agency (NTA); and

4. **Whereas**, JKBOPEE vide Notification No.041-BOPEE of 2023 dated 15.07.2023 notified for the online registration of NEET-UG 2023 candidates belonging to UT of J&K/Ladakh; and

5. **Whereas**, the J&K BOPEE vide Notification No.045-BOPEE of 2023 dated 27.07.2023, issued the Provisional Merit List (PML) of NEET-UG-2023 candidates belonging to UT of J&K and Ladakh and subsequently vide Notification No.048-BOPEE of 2023 dated 31.07.2023 notified the conduct of online counselling of eligible candidates of NEET-UG 2023 for filling up of online preferences and updated rank wise provisional merit list.

6. **Whereas**, vide Notification No. 057-BOPEE of 20023 dated 11.08.2023 JKBOPEE issued the Provisional Selection List of the eligible candidates for UT of J&K/Ladakh for NEET-MBBS/BDS Courses, 2023 and in the said Notification No. 057-BOPEE of 2023 dated 11.08.2023 it was clearly mentioned in Note para 1 and 2:

“1. The admission of the candidates is purely provisional and shall be liable to be cancelled in case any information furnished by any candidate proves to be false/ fabricated, and action as warranted under law shall be initiated against such candidates.

2. It is hereby implored upon the management of all colleges/ institutions to ensure the veracity of documents, particularly the category certificates wherever the admission is to be granted in lieu of a particular reserved category. So far as the persons with disability are concerned, if selected in open merit or against a reserved category it shall be ensured that his/ her PwD certificate /eligibility is in conformity with NMC(MCI) /DCI guidelines, regulations framed by the concerned regulatory

authority and wherever required shall refer the matter to concerned Medical Board to assess such candidates and make recommendations based on which institution shall take further necessary action. In case any candidate does not fulfill the benchmarks of eligibility as per NMC/DCI guidelines, his/ her admission shall be cancelled on his/ her risk and responsibility under intimation to the Board.”

7. **Whereas**, accordingly, in pursuance of the above said notification, SKIMS Medical College Bemina Srinagar referred the candidates provisionally selected under PwD category including above named Ms. Safiya Jan D/o Jan Mohammad R/o Tarabal Nawakadal Srinagar Roll number 2502110272 and UT Rank 2647 who has been selected under PwD category vide notification No. 057-BOPEE of 2023 dated 11.08.2023 to the designated Medical Board to assess and verify the genuineness of their disability certificates ;*and*
8. **Whereas**, after due examination and assessment, the constituted Board /Experts submitted their Report and in light of the same, the authorities at SKIMS Medical College Bemina Srinagar, vide letter No. SKIMS/MC/Acad/3162-68, dated: 21.12.2023 communicated the specific recommendations regarding admission of the above-mentioned Ms. Safiya Jan provisionally selected under the PwD category, (verbatim) as under:

“1. Safiya Jan D/o Jan Mohammad Khan

Con. No 9622748667 (S.No. 1191)

After examination/ evaluation of the documents of the candidate which were not sufficient for confirmation of Thalassemia intermedia and the committee opined that the said candidate will have to be examined

further by the Hematology, Department SKIMS Soura. Accordingly the candidate was referred to HoD Hematology for evaluation and the report received from the HoD Hematology informed that the said candidate has undergone baseline investigations (under patient Id No. 3043274). Her CBC, LDH, Total Bilirubin are not suggestive of Thalassemia Disorder. Moreover, there is no documented evidence of any blood transfusion of the candidate till date. Hence she does not fulfil the criteria for PwD category.

Also her disability certificate (JK101162000069712) has been cancelled by the JK Medical Board as mentioned in their website; and

9. Whereas, besides the above, it has also been intimated that an application submitted by the above named Ms. Safiya Jan D/O Jan Mohammad Khan, before the Principal SKIMS, MCH on 09.10.2023, was forwarded to the office of Registrar Academics SKIMS Soura, wherein said Safiya Jan requested for cancellation of her admission; *and*

10. Whereas, however, subsequently above named Safiya Jan submitted another application and requested that her previous application regarding cancellation of admission may not be considered; *and*

11. Whereas, notwithstanding the above, said Ms. Safiya Jan submitted another application on 13.11.2023 requesting once again for cancellation of her admission; *and*

12. Whereas, in view of the Medical examination report/recommendations furnished by the SKIMS Medical College Bemina Sringar, and the attendant facts and circumstances, it emerges that Ms. Safiya Jan D/O Jan Mohammad R/O Tarabal Nawakadal Srinagar does not fulfil the requisite criteria of eligibility for admission to Medical Course(MBBS) under the category of *Persons with Disability (PwD)* and further she has

produced false/ fabricated information and concealed material facts with the intention to mislead; *and*

13. **Whereas**, Section 22 of J&K Reservation Act 2004 under the heading Penalty for contravention of the provisions of the Act, clearly states that:

“Any person who obtains a certificate under the Act by misrepresentation, fraud or concealment of any material fact or impersonation shall, in addition to prosecution under the law for the time being in force, be liable to

- a) cancellation of the certificate and forfeiture of benefit;
- b) removal or dismissal from service; and
- c) fine of not less than rupees ten thousand.”

14. **Whereas**, the above factual position clearly demonstrates that the candidate has not only managed to get the provisional admission in the MBBS course by fraudulent means but also spoiled the career of a meritorious candidates, who may have got admission on the said seats in place of Ms. Safiya which act on her part not only warrants cancellation of her provisional admission in terms of the relevant rules but is also liable to be proceeded against as per the law.

15. **Whereas**, consequent upon the report of the Special Medical Board of the SKIMS Srinagar, conducted on the Provisionally selected said candidate Ms Safiya admitted in the SKIMS Srinagar made under PwD Category for MBBS Course for the session 2023-24 is required to be cancelled ab-initio as per the mandate of the Board which has made the selection of the said candidate in the SKIMS Srinagar with the approval of the competent authority in the said category on the basis of the requisite category certificate which has now been proved to be not in consonance with the benchmark disability of the candidate; and

16. **Whereas**, the concerned candidate has managed to get admission in the Professional Course (MBBS) on the basis of a fake/forged certificate, as established by the concerned department and as such her admission is liable to be cancelled and action as warranted under rules is required to be initiated against her for this act;

Now, therefore, in view of the above factual position the provisional admission of Ms. Safiya Jan D/o Jan Mohammad R/o Tarabal Nawakadal Srinagar for pursuing the MBBS-Course in the SKIMS Medical College Bemina, Srinagar in pursuance of the provisional selection made by the J&KBOPEE vide Notification No. 057-BOPEE of 2023 dated 11.08.2023, shall and shall be deemed to have been cancelled ab-initio.
