Vide Notification No. 11 of 2024 dated 20-09-2024 of Indian Nursing Council (INC) the last date of admission for all Nursing Programs for Academic Year 2024-25 has been extended up to 31.10.2024. Now in pursuance of Notification No. 089-BOPEE of 2024 dated 30.08.2024 read with Notification No. 115-BOPEE of 2024 dated 20.09.2024 & due to paucity of time, it is hereby notified that the Board shall conduct 3<sup>rd</sup> Round of counseling for admission to B.Sc. Nursing/B.Sc. Paramedical/B.Sc. Technology Courses-2024 (All Candidates including Reserved Category Candidates) in various Government/Private Colleges of UT of J&K. It is further notified that in order to fill maximum number of seats & to accommodate more candidates, the Board has decided to reduce the bench marks from 45 to 25 marks for this round of counselling and therefore those candidates who have secured up to 25 marks in the Common Entrance Test conducted by the Board for said courses shall be eligible to attend counseling as per the following schedule:

It is further notified for information of all the concerned candidates that the upgradation/allotment of seats during the 3<sup>rd</sup> Round of Counseling shall be purely on provisional basis and shall not confer any preferential right upon the provisionally selected candidates and shall be subject to the outcome of writ petition, if any, sub-judice in any competent court of law on the subject. All the candidates who are participating in the counseling shall bring along the following documents in original on the day of their counseling failing which they shall not be allowed to attend the counseling:

- i) Domicile certificate,
- ii) Marks card of 12th class examination,
- iii) D.O.B as per matriculation certificate,
- iv) Category certificate, wherever applicable,
- v) Diploma for Lateral Entry Candidates only.

**Note -I:**

The following procedure shall be followed during the 3<sup>rd</sup> Upgradation/Allotment Round of Physical Counseling.

1. The eligible candidates have to report at the BOPEE offices Jammu / Srinagar for Registration/Attendance & fulfillment of other formalities, from 08.30 a.m. to 10.00 a.m. on the day/date of counseling for above Courses.
2. It is enjoined upon all the eligible candidates that they shall visit/ attend counseling only after checking the Seat Matrix available on the official website of the Board.
3. Those candidate(s) who have been allotted seat(s) during the First and second Round of Counseling and have joined against the said seat/ College, if interested, for upgradation are eligible to participate in the 3<sup>rd</sup> Round of Physical Counseling with the condition that he/she shall have to produce his/her fee deposition receipt of the concerned allotted College at the time of Registration/Attendance on his/her day/date of counseling.
4. The Board shall notify the Provisional Selection list of the candidates indicating Application Number, Name, Gender, Category, Name of Institution and Discipline after conclusion of the counseling.
5. The candidates who are participating for the first time in the counseling process shall have to deposit Rs.1000/ as a Counseling fee through POS machines available at BOPEE office Jammu/Srinagar on their day/date of Counseling

6. The Board reserves the right to notify such changes as may become necessary in view of any technical difficulty or the reasons beyond its control.

**Note -II:**

**The Seat Matrix for 3<sup>rd</sup> Round of counselling shall be uploaded on website of the Board before counseling for information of the candidates. The counseling will be automatically stopped as and when the seats will be filled and no claim(s) from the waiting candidates, if any, shall be entertained by the Board.**

The other Terms and Conditions shall, however, remain the same as notified by the Board in various Notifications/Notices issued from time to time in this regard.
