It is further notified that the candidates may go through the Notification carefully as only the following candidates shall be eligible to participate in this round of counseling and in case of non-fulfillment of the conditions mentioned herein below such candidate(s) are not eligible to participate in this round: -

- 1. The candidates who have not been allotted any seat during 2nd and 3rd/Mop-Up Rounds of counselling shall be eligible to participate in this Special Stray Vacancy Round.
- 2. The candidates who have been allotted a seat during the 2nd Round of counselling and have joined the college but have not been upgraded during the 3rd/Mop Up Round shall be eligible to participate in this round of counseling.
- 3. The candidate(s) who has been allotted seat during 1st Round of Counseling but has not joined against the said allotted Seat/College shall also be eligible for Special Stray Vacancy Round of counseling. However, any candidate upgraded during Mop Up Round of counseling shall under no circumstances be eligible to participate in the Special Stray Round.
- 4. The candidates who have been allotted seat(s) in AIQ Mop-up/Stray/Special stray round(s) of counseling and have joined the respective allotted College/Institution shall not be eligible to participate in this special stray round of counseling.

The Board shall firstly conduct the counseling of Horizontal and Reserved Category candidates on **30.10.2024** and if any reserved category seat(s) remains unfilled due to non-availability of eligible candidates, then those seats shall be converted into O.M in terms of Section 9(2) of J&K Reservation Act, 2004 and shall be filled up accordingly as per merit.
