Mopping up round of counselling of MD/MS/PG Diploma courses, 2018 - change in

schedule.

NOTICE NO. 036 -BOPEE OF 2018 DATED 10-05-2018

Whereas, the Board had notified the mopping up round of counselling on 11-05-2018 vide Notice No. 035-BOPEE of 2018 dated 09-05-2018 in view of closure of admission process on 12-05-2018; and

Whereas, the Hon'ble Supreme Court vide its Order No. 1191 of 2018 in WP (C No. 76 of 2015) dated 10-05-2018 in IA No. 61874/2018-Direction), has been pleased to grant extension in time for completion of the admission process of MD/MS/PG Diploma courses by one week i.e. upto 25-05-2018, which shall be 19th May, 2018 against 12-05-2018 in the mop up round;

Now, therefore, consequent upon the above, the following adjustments are hereby notified in the admission schedule:-

- i) The joining time for the category candidates whose counselling is being done today the 10th May, 2018 shall now be upto 12-05-2018 (4.00 p.m.);
- ii) Submission of shortfall etc by the colleges shall be upto 12-05-2018 (4.30 p.m.);
- Date of submission of resignation in the colleges is now extended upto 12-05-2018 (4.00 p.m.) instead of 10-05-2018 (2.00 p.m.);
- iv) The mopping up round shall now be conducted on 13-05-2018 instead of 11-05-2018. The registration shall commence from 9.00 a.m. to 10 a.m. However, those candidates who have resigned shall not be eligible for mopping up round as notified hithertofore;
- v) The candidates allotted seats during mopping up round shall have to join the college upto 17-05-2018 (4.00 p.m.);
- vi) Forwarding of list to colleges, if required on 18-05-2018.

Other terms and conditions shall remain the same as notified hithertofore.
