While scrutinizing documents of the candidates for NEET UG, 2018 during the process of registration, it has been found that some candidates have not uploaded the marks card of 10+2 issued by the CBSE. Many representations have also been received that such candidates have not received the marks cards from the CBSE as their results have been declared recently.

The matter has been examined by the Board and it has been decided to allow such candidates to participate in the counselling process subject to fulfillment of other conditions of eligibility at their own risk and responsibility and subject to the production of original marks card at the time of admission to the course in case selected by the BOPEE. Further, as a provisional measure the candidates may have the electronic marks cards certified/authenticated by the concerned Principals and deposit a copy of the same in the BOPEE Offices at Jammu/Srinagar.
