Subject:- Preparation of documents for Central Pool MBBS Seats.

It is for the information of the those candidates, who wish to compete under central pool MBBS/BDS quota for the year 2018-19, which the Ministry of Home and Ministry of Health and Family Welfare, Government of India have been allocating to J&K State for nomination of MBBS/BDS seats outside the state in different Medical/Dental Colleges of the country in terms of the Guidelines issued by the respective Ministries. The guidelines of the respective ministries and the necessary documents required to be furnished by the prospective eligible candidates are given at Annexure "A" to this Notice. All the intending candidates who have qualified NEET undergraduate MBBS Course conducted by Central Board of Secondary Education (CBSE), 2018 and wish to apply for MBBS/BDS course under central pool are informed in advance that they should in their own interest keep the documents mentioned in the Annexure "A" ready so that they do not face any difficulty in applying as and when the seats if any are allocated to the state of J&K by the concerned Ministries under Central Pool Quota. They are further informed that the mere preparation of documents will not confer any right on the candidates to stake a claim and the candidates will be considered only as and when the seats are notified by the respective Ministries to the State of J&K, which are usually notified to the state governments during the month of July/August and the admission are to be completed as per the schedule notification of Ministry of Home and Health and Family Welfare, Government of India.
