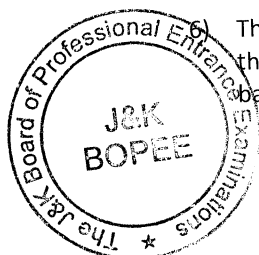
Consequent upon submission of the shortfall of engineering seats due to non joining of candidates, who were recommended admission vide Notification No. 59- BOPEE of 2018 Dated: 24-06-2018 along with the seats which had remained vacant during the first round of online counselling, the second round of counselling (physical) upgradation/allotment shall be held w.e.f.17-07-2018 to 23-07-2018 as per the following schedule in the Board Offices at Srinagar/Jammu:-

The candidates with score of up to 10 marks in the Entrance Test shall be eligible to participate in this round of counselling subject to the following conditions:-

- 1) In view of large number of shortfall received by the Board and with a view to fill the seats, all candidates who have joined/ not joined the course/college shall be eligible to participate in the process of counselling/upgradation;
- 2) The candidates, who participated in the first round of counselling but could not get a seat due to (SNA)/or CNA shall also be eligible to participate in the counselling;
- 3) The candidates, who did not participate in the first round (online) of counselling for one or the other reason or did not make the online fee payment shall also be allowed to participate in the counselling;
- 4) The eligible candidates, who are desirous of participating in the physical round of upgradation/allotment shall be required to fill in fresh preference forms and the preference forms filled online during first round shall be deemed to be cancelled;
- 5) The candidates shall have to appear during the upgradation/physical round in person before the counselling committee/Board as per the above schedule. The candidates shall have to register themselves in the Board office in the morning and shall have to participate in the counselling process on their turn. The seat shall be allotted to the candidates, who participate in the counselling at relevant point of time on the basis of merit-cum-preference. In case, any candidate fails to appear in the counselling at his/her turn he/she shall lose claim on the seat available, which shall be allotted to the next available candidate in order of merit. However, such a candidate who missed the counselling on his/her turn and reports at a later date/time of his/her turn during the counselling period as notified, shall only be considered against the seat(s), which are available at that point of time;

The seats vacated by the candidates due to upgradation etc shall be added to the seat matrix during the day on minute to minute basis and the seat matrix shall undergo change on minute to minute basis, which shall be displayed on the monitors available in the BOPEE Office, Jammu/Srinagar.



- 7) The other conditions contained in the Information Brochure (except that the candidates who have not joined the colleges and are allowed to participate in the counselling now) shall apply mutatis mutandis during the allotment/upgradation round. The candidates in their own interest are advised to go through the procedures laid down in the CET Information Brochure; and
- 8) The tentative seat matrix for second round of counselling of CET (Engineering), 2018 shall be available on the BOPEE Official website www.jkbopee.gov.in
