Consequent upon the shortfall received from the Government College of Education (GCOE), Canal Road, Jammu vide letter No. GCOE/J/2018/913 dated 30-0-8-2018 and the seats allotted to candidates vide Notification No. 097-BOPEE of 2018 dated 18-08-2018, the candidates figuring in the list annexed as **Annexure "A"** to this notification, have been provisionally selected for admission to B.Ed. Course 2018 in GCOE, Jammu on the basis of merit, with due regard to reservation policy for the academic year 2018. The Principal of the College shall allow the candidates to join only after verification of requisite documents in original as notified vide Notification No. 073-BOPEE of 2018 dated 23-07-2018. The candidates so selected shall report for admission in the GCOE, Jammu up to **12<sup>th</sup> September, 2018 (4:00 p.m.)** and the College shall send the **Short fall, if any, on 12<sup>th</sup> of September, 2018 up to 5:00 p.m.** to the BOPEE office, Jammu / Srinagar positively.

**NOTE:**

1. The Principal of the Institution shall ensure that only those candidates whose documents are admitted to the College, whose documents are complete in all respects. The candidates found deficient of documents figuring during the verification of documents / certificates (including Marks Card), should under no circumstances be allowed admission. The Head of the Institution shall solely be responsible for any lapse in this regard.
2. Mere enlisting of any candidate in the annexed list will not confer any right upon him/her, if found otherwise ineligible.
3. In view of the shortfall received from the Principal, Govt. College of Education Canal Road, Jammu based on which the candidates as per Annexure "A" have been selected the category candidates bearing Rank 163 (ALC) & 167 (SC) selected vide Notification No. 073-BOPEE of 2018 Dated: 23-07-2018 have now been treated as Open Merit (OM) candidates.





4. The Rank 505 (RBA) who had failed to take admission on the basis of 1<sup>st</sup> provisional select list forwarded vide Notification No. 073-BOPEE of 2018 dated 23-07-2018 is recommended again in view of request having been made by her for reconsideration.
