



**Subject:- Admission to MD/MS/PGD Courses, 2019 -second round of physical counselling (upgradation round/allotment) – schedule thereof.**

**Notification No. 023-BOPEE of 2019 Dated 15-04-2019.**

In view of some technical issues and the reasons beyond its control, the Board has now decided to conduct second round of counselling (upgradation/allotment) round through physical counselling. Accordingly, the schedule notified vide Notification No. 021-BOPEE of 2019 dated 12-04-2019 would undergo a change. The physical round of counselling for the unfilled seats shall be held on 19<sup>th</sup> and 20<sup>th</sup> April, 2019 and if need be 21<sup>st</sup> April, 2019 shall also be utilized for the purpose. The revised schedule shall, therefore, now be as under:-

The candidates are advised to go through the Information Brochure before participating in the second round of physical counselling. For facilitation of the candidates relevant portion of the counselling as notified in the e-brochure is available on the BOPEE website [www.jkbopee.gov.in](http://www.jkbopee.gov.in) and also attached as Annexure 'A' to this Notification. Further, the tentative seat matrix is attached herewith as Annexure 'B' to this Notification. However, only such candidates shall be eligible to participate in the counselling:-

- (i) Who have joined the college/Institution during the first round of counselling.
- (ii) The candidates who did not get a seat during the first round of counselling/who did not get a seat due to choice not available in the first round of online counselling.
- (iii) Those who figure in the PSML but did not participate during the first round of counselling.

Further:-

- (i) In case the candidates are not upgraded on the basis of the fresh preferences given by them, they shall retain the seat allotted to them during the first round of counselling. However, if a candidate is upgraded as per the preferences filled in by him during the physical second round of counselling, the seat allotted to him during the first online round of counselling shall be added to the seat matrix at that relevant point of time and allotted on the basis of merit cum preference and the candidate shall have no claim whatsoever on the seat held by him prior to upgradation.
- (ii) Those who are participating for the first time in the counselling shall have to pay fee of Rs.2000/- through POS machines available in the BOPEE Office, Srinagar/Jammu.
- (iii) The candidates who have applied under NRI/Hindu Minority Quota in ASCOMS in pursuance of Notice No.25-BOPEE of 2019 dated 18-03-2019 read with Notice No. 29-BOPEE of 2019 dated 08-04-2019 shall only be eligible to compete against such seats.
- (iv) The Open Merit unfilled seats in ASCOMS, if any, shall be filled up during the second round of physical counselling.
- (v) The candidates, should fill up the preferences carefully and take a conscious decision whether to participate in the physical second round of counselling or not.
- (vi) The terms and conditions for mopping up round shall be the same as notified in the Information Brochure and candidates are, therefore, advised to go through the said conditions carefully.
- (vii) The Board reserves the right to notify such changes as may become necessary in view of any technical difficulty or the reasons beyond its control.







- (viii) The candidates should carefully decide about retention of the seats and resign, if they so decide, upto prescribed date, failing which they shall be debarred from participation in the admission process for three years/two years as the case may be in terms of SRO 48 of 2018 dated 30-01-2018 as leaving the seat midway or after the last date fixed for submission of resignation shall attract the provisions of the said SRO.
- (ix) Board may consider filling up the seats arising due to resignation, on 6<sup>th</sup> and 7<sup>th</sup> May, 2019, to enable the Board to complete the process in a time bound manner.
- (x) The tentative seat matrix to be operated upon during the second round of counselling has been uploaded on the website [www.jkbopee.gov.in](http://www.jkbopee.gov.in). This seat matrix shall undergo such changes as may become necessary due to allotment of the seats in the upgradation process and vacation of the seats by the candidates. It shall also include the unfilled category seats having remained vacant and notified vide Notification No. 18-BOPEE of 2019 dated 01-04-2019.
- (xi) The above schedule is in partial modification of the dates, if any, contrary to those notified in the Information Brochure and in Notification No. 21-BOPEE of 2019 dated 12-04-2019 due to administrative and other requirements.

**Note:-**

- (i) The candidates shall have to produce proof of identity before they are allowed to participate in the physical counselling as no proxy shall be allowed. Impersonation, if noticed, shall be dealt with strictly in accordance with the law.
- (ii) The candidates shall have to fill up the fresh preferences and those submitted during the first round of online counselling shall be deemed to have been cancelled.
- (iii) Unfilled seats, if any, on 20<sup>th</sup> April, 2019 shall be notified and filled up on 21-05-2019 in accordance with the same procedures.
- (iv) The counselling shall be held at Board Offices at Jammu and Srinagar simultaneously through video conferencing for facilitation of the candidates. Therefore, the candidates shall have the option to participate in the physical counselling at per their convenience.
- (v) **The candidates are advised not to park any vehicle around the Board Office as it creates problems for the local residents and also for the Board management. The candidates are advised to park the vehicles at the parking places notified by the Government for the purpose.**

The above shall be subject to outcome of writ petitions, pending, if any, before any competent court of law.

**1. UPGRADATION/ALLOTMENT ROUND(2ND ROUND OF COUNSELLING)**

Following procedure shall be followed in case it is decided by the Board to conduct upgradation/allotment round (2<sup>nd</sup> round of counselling) through physical counselling:-

- i. The seats available due to non joining, resignation etc shall be notified by the BOPEE. All candidates who have joined the course/college and those to whom a seat could not be allotted during the first round of counselling due to SNA/CNA shall be eligible to participate in the process of counselling/upgradation and those who have not joined on allotment of the seat during the first round shall not be eligible;
- ii. The candidates eligible and desirous of participating in the physical round of upgradation/allotment shall be required to fill in fresh preference forms and the preference forms filled online during first round shall be deemed to be cancelled;
- iii. The candidates shall have to appear during the upgradation/physical round in person before the counselling committee/Board as per the schedule notified by it. The candidates shall have to register themselves in the Board office in the morning and shall have to participate in the counselling process on their turn. The seat shall be allotted to the candidates who participate in the counselling at relevant point of time on the basis of merit-cum-preference. In case any candidate fails to appear in the counselling at his/her turn he/she shall lose claim on the seat available, which shall be allotted to the next available candidate in order of merit. However, such a candidate who misses the counselling on his/her turn and reports at a later date/time than of his/her turn during the counselling period as notified, shall only be considered only against the seat(s), which are available at that point of time; and
- iv. The seats vacated by the candidates due to upgradation etc shall be added to the seat matrix and allotted during the day on minute to minute basis and the seat matrix shall undergo change on minute to minute basis, which shall be displayed on the monitors available in the BOPEE office.

Note:- (i) Rule 17 shall not apply during the upgradation/allotment round. The candidates upgraded/allotted a seat shall be required to join the

college within the stipulated time as may be notified by the Board; and

- (ii) The physical round of counselling may either be conducted on a single day or on different dates/days as may be notified by the Board. Such seats remaining unfilled at the conclusion of first days of counselling may be carried to the next day/date of counselling as may be decided by the Board. However, the candidates who did not participate in the counselling process on a particular date/day notwithstanding his/her higher merit shall subject to the above conditions be eligible to compete for the seats as are carried forward to the next day/date of counselling. Such candidates shall have no claim on a seat which was allotted to a candidate during the previous day/date of counselling on the basis of his/her merit, preference and availability of seat at the time of counselling. In other words the candidates cannot stake a claim on a seat which has been allotted to another candidate on the grounds that the candidate could not participate in the physical round of counselling earlier when the seat was available. Such a process, if allowed would mean re-opening of admission/allotment process and thereby result in non completion of admissions within the stipulated/prescribed time limit by the MCI/Hon'ble Supreme Court of India;
- (iii) The candidates participating in the physical round of counselling and allotted a seat, should in their own interest not leave the Board office as there is a possibility that a seat of his/her choice, which was not available on his/her turn of counselling, may become available in the process. He/she can stake a claim on such a seat immediately once the seat is displayed on the monitor of the Board, consequent upon its vacation by a candidate so that such a candidate is considered for allotment of the seat on merit cum preference basis. The seat allotted to him/her earlier shall become vacant

and added to the seat matrix. Board shall not be responsible in case a candidate leaves the Board office and he/she fails to stake a claim on a seat as may become available as above.

- (iv) The seats additionally allowed to be filled by the MCI/Government of India, after the completion of first round of counselling and before the filling up of fresh preferences for second round of counseling shall be added to the seat matrix and filled up along with the other seats being filled up during such round.

## **2. SUBSEQUENT ROUND OF COUNSELLING:**

The Board may, if it is expedient to do so, conduct subsequent round of online counselling/physical round of counselling in the same manner as prescribed for 2<sup>nd</sup> round of counselling provided that:-

The candidates, who did not join the college on allotment of a seat after first round of counselling or on upgradation of seat and or allotment of seat during second round shall not be eligible to participate in the subsequent round of counselling. Those candidates, who have been upgraded during the second round shall not be eligible to participate in this round, notwithstanding his/her joining the College.

## **3. NRI/HINDU MINORITY QUOTA:**

The seats under HMQ and the NRI in the ASCOMS shall also be filled up through a process of joint physical counselling after the above process is completed. Only such candidates shall be allowed to participate in the counselling for such seats, who fulfill the eligibility as laid down in the e-brochure and who figure in the Provisional State Merit List prepared on the basis of registration of candidates. Such candidates shall be required to produce such other additional documents as mentioned in the e-brochure or as may be further decided by the Board to ensure that only genuine and eligible candidates are considered against such seats.



4. CONVERSION OF CATEGORY SEATS IF ANY/FINAL ROUND BY PERSONAL COUNSELLING (MOPPING UP ROUND):

If otherwise required, the **Board** will issue Notification of final round by Personal Counseling on its website [www.jakbopee.org](http://www.jakbopee.org) and [www.jkbopee.gov.in](http://www.jkbopee.gov.in) indicating schedule of selection process for final round for allotment of seats remaining vacant after completion of earlier round(s) of allotment of seats by way of Preference Forms. This final round of allotment of seats shall be conducted by way of personal counselling instead of allotment on the basis of Preference Forms to ensure that all the vacant seats are filled in before **18<sup>th</sup> May, 2019** and there will be instant seat allocation. All the candidates who have qualified the NEET 2019 but could not be allocated seats in earlier rounds and have submitted the documents in BOPEE office will be eligible to appear in the final round of counselling. Those who had not submitted the documents shall, in no case, be considered, notwithstanding their merit position. **The unfilled category seats shall also be filled up during the final round and by adding the same to the seats available.**

On account of allotment of seats in this final round of admission, no fresh vacancies consequent upon allotments made in this round will be created. This is principally because this final round of allotment is meant to fill up (as far as possible all) available vacant seats without creating a new or fresh vacant seat on account of such allotment. During this round also, eligible candidates will appear personally (**Proxy will not be permitted**), seeking allotment of seats of their choice. Personal counseling for such allotment will be held strictly in order of State Merit List number of NEET-PG/MDS, 2019. Each candidate will be offered all seats that have remained vacant and are available for allotment as per merit and preference only at time of his/her turn of counseling i.e. State Merit Position. The available seats shall be offered to the next candidate in merit.

Before personal counseling round, all available vacant seats (due to non- allotment / non-joining / resigning/ unfilled category seats to be converted to OM) will be notified on website. Eligible candidates interested to participate in this round should carefully go through vacant seats as notified on website and decide whether to participate in the Final Personal Counseling round. Such candidates, in their own interest are advised however, to be available in the BOPEE office during the mopping up round to stake a claim on the available seats.

For the purpose of this Personal Counselling round, following seats shall be considered as available for admission which will be displayed on website before commencement of Personal Counseling round :-

- a) All seats that have remained vacant, if any, at the end of previous admission round(s) on



account of non-allotment;

- b) All seats that were allotted in previous round(s) but were rendered vacant on account of candidate to whom such seats were allotted but did not join or resigned;
- c) All unfilled category seats to be converted into OM;
- d) All such seats that may become additionally available on any account whatsoever, including but not limited to seats if any additionally recognized by Medical Council of India made additionally available on account of any Order that may be passed by Courts etc.

In aforesaid final round of admission by personal counseling, preference forms submitted by all eligible candidates will not be considered and same shall be treated to have been cancelled. In other words, this final personal counseling round shall not be conducted on the basis of choices given in preference forms submitted by candidates, but on the basis of the merit-cum-preference of such candidates who are available at that time/date.

All candidates to whom seats will be allotted in accordance with choice and available seats at his/her merit position at time of personal counseling, will be required to join concerned college and complete all necessary formalities (by submitting all original documents and paying prescribe fees) for taking admission accordingly within prescribed time.

Allotment of seat once made in this personal counseling round shall not be changed. At the time of this personal counseling round, candidates must consider available seats thoroughly and opt for a seat which they must join once allotted.

It is made hereby clear that in case such a candidate does not join concerned College and/or fails to comply with necessary formalities, his/her admission shall be cancelled.
