NOTIFICATION NO.119-BOPEE OF 2018 DATED 06-11-2018

Consequent upon the fifth round of counselling held on 06-11-2018 in pursuance of Notice No. 082-BOPEE of 2018 dated 30-10-2018 read with Notification No. 118-BOPEE of 2018 dated 01-11-2018, the list of candidates as admitted/upgraded to various AYUSH/BPT Courses/Colleges is given in the Annexure Á' to this Notification. The candidates so admitted/upgraded shall have to join the Institutions/Courses latest by 10th of November, 2018 (4.00 p.m). The Colleges/Institutions shall furnish the shortfall, if any, by 5.00 p.m. on the same date/day viz 10-11-2018. The Colleges shall, however, allow the candidates to join the Colleges/Institutions only on production of all original certificates as notified earlier from time to time.

Further date for counselling, if required, within the cut off date of 15-11-2018, after receipt of the shortfall, if any, from the colleges/institutions shall be notified separately. In pursuance of communication No.F. No.R-13040/33/2016-HD (Tech) Part dated 01-11-2018 from Ministry of Ayurveda, Youga & Naturopathy, Unani, Siddha and Homoeopathy (AYUSH), the cut off merit for AYUSH courses has been revised as under:

OM = 86 Score (35th percentile) Category = 67 Score (25th percentile)

The cut off score for BPT courses shall be 65 marks as notified earlier.

As of now, all seats notified by the Board in various Colleges/Institutions have been filled up except in case of JIAR, which were not notified by the Board as the Ministry of AYUSH has not granted permission to the College to fill up the seats during 2018-19. The Institute has however, filed writ petition OWP No. 22018/2018 before the Hon'ble High Court at Jammu challenging the order dated 26-09-2018 issued by the Ministry and the matter is pending before the Hon'ble High Court.
