Filling up of vacant seats BAMS UG/PG seats in JIAR in compliance of orders of the Hon'ble High Court at Jammu dated 20-12-2018 in contempt petition No. CP-OWP/323/2018 arising out of OWP No. 2208/2018 titled Jammu Institute of Ayurveda & Research Vs Union of India & Others.

NOTIFICATION No. 121-BOPEE OF 2018 DATED 22-12-2018

In compliance and with due deference of the orders of the Hon'ble High Court dated 20-12-2018 passed in the Contempt Petition No. CPOWP323/2018 arising out of OWP No. 2208/2018 titled Jammu Institute of Ayurveda & Research Vs Union of India & Others, as conveyed by the Sr. Additional Advocate General Mr. C. M. Kaul on phone, it is notifed that the counselling of the unfilled seats of BAMS UG/PG in JIAR for the year 2018 shall be conducted on 26-12-2018 and 27-12-2018 in the Board Office at Srinagar/Jammu simultaneously as under:-

- 67 seats (60 OM, 07 P&B) BAMS (UG) 26-12-2018
- 09(Three each in Krayasharir, Shalaya Tantra, Kayachikitsa) 2. BAMS (PG) 27-12-2018

The eligibility for counselling for UG Courses shall be as under:-

i) OM NEET score 86 and above;

Reserved categories ii)

NEET score 67 and above.

The admission shall be only for BAMS in JIAR iii)



The eligibility for PG Courses:-

Only such candidates, who are the State subjects of J&K, shall be eligible to compete with the following score obtained in the Test conducted by the AIAPGET, 2018:-

- i) OM = $30 \text{ marks} (50^{\text{th}} \text{ percentile})$
- ii) $SC/ST = 25.5 \text{ marks } (40^{th} \text{ percentile})$
- iii) RBA/ALC/OSC = 27.5 marks (45th percentile)

Other conditions:-

- i) The candidates who are desirous of participating in the counselling shall have to report in the BOPEE Office at Jammu/Srinagar at 10.30 a.m. on the scheduled date for registration to be eligible for counselling;
- ii) Those candidates, who are appearing in the counselling for the first time and fall within the above cut off merit shall have to deposit a counselling fee of Rs.1500/through POS machines available in the BOPEE Office after which they will be allowed to participate in the counselling process on the basis of merit;
 - The candidates who have paid the counselling fee either online or offline in pursuance of various Notifications issued by the Board earlier on the subject need not to pay again;
 - The candidates who have not registered earlier either online or offline but are interested to participate in the counselling process shall have to bring with them all the documents in original along with self-attested copies of the same before they are allowed to participate in the counselling. The documents required to be produced have been notified from time to time through various notices/notifications issued by the Board;
- The candidates competing for PG seats shall have to indicate the preferences for the seats/courses and the seat shall be filled up on the basis of merit cum preference;
- vi) No further vacancy in BAMS/BUMS courses shall be created as a consequence of the said counselling, which has being done purely in implementation of the Hon'ble High Court orders as referred to above; and
- vii) The conditions not specified here but mentioned in Information Brochure/other Notices/Notifications issued on the subject by the Board shall apply mutatis mutindus to the present counselling process;

Since the permission granted by the Ministry of AYUSH, Government of India to JIAR for running the said courses has been withdrawn vide Order dated 26-09-2018 in view of various shortcomings and deficiencies as mentioned in the said order, which order has been challenged by the JIAR before the Hon'ble High Court at Jammu in OWP No. 2208/2018 and the interim directions have been passed in the said writ petition, therefore, the counselling shall be purely provisional and subject to such other orders as may be passed by the Hon'ble Court/final outcome of the writ petition No. 2208/2018 pending before the Hon'ble High Court at Jammu.
