In pursuance of Notification No. 121-BOPEE of 2018 dated 22-12-2018, and in compliance and with due deference of the orders of the Hon'ble High Court dated 20-12-2018 issued on 27-12-2018 in the Contempt Petition No. CPOWP 323/2018 arising out of OWP No. 2208/2018 titled Jammu Institute of Ayurveda & Research Vs Union of India & Others, the counselling for the MD/MS (Ayurveda) seats in JIAR, Jammu was held on 27-12-2018 in the Board Office at Srinagar/Jammu. Consequent upon the said counselling, the list of candidates **provisionally recommended** for admission in the MD/MS (Ayurveda) course in JIAR, Jammu is given in the **Annexure Á'** to this Notification.

During the process of counselling, there was a tie of marks between two candidates at Rank 2667. The Board having considered the matter in accordance with the procedures/rules decided to break the tie by applying the age criteria viz the candidates elder in age was placed above the candidate younger in age and accordingly the allotment of seats was made.

The candidates so admitted shall have to join the Institution/Courses latest by 1st of January, 2019 (4.00 p.m.). The College shall, however, allow the candidates to join the Institution only on production of all original certificates as notified earlier from time to time.

The College shall submit the list of admitted candidates to the BOPEE on **01-01-2019 by 5.00 p.m.** along with the documentary evidence of the fee paid by the candidates for record and reference of the Board.

While admitting the candidates to the College, the Management/the concerned shall apprise the candidates of the conditions contained in the Hon'ble High Court Order dated 20-12-2018 issued on 27-12-2018.

The other terms and conditions shall remain the same as notified from time to time.

As notified vide Notification No. 121-BOPEE of 2018 dated 22-12-2018, the admission is purely provisional and subject to such other orders as may be passed by the Hon'ble High Court /final outcome of the writ petition No. 2208/2018 tiled Jammu Institute of Ayurveda & Research Vs Union of India & Ors. pending before the Hon'ble High Court at Jammu. In further compliance of the orders of the Hon'ble High Court dated 20-12-2018 issued on 27-12-2018, the conditions laid down by the Hon'ble High Court in the said order have been read out and explained to the candidates during the courselling.
