Subject: - NEET PG admission 2019 – submission of documents/participation in the online registration by candidates pursuing PG/those who have left the course midway – non eligibility thereof in terms of SRO 48 dated 30-01-2018.

During online registration and submission of documents by the candidates willing to participate in the further admission process and on preliminary screening of the application forms it has been observed that:-

- i) Some candidates who are pursuing PG/PG Diploma have also applied for admission during 2019;
- ii) Some candidates who were granted admission during 2017 and 2018 in Medical Colleges of the State but have resigned after the cut off date/left the course midway have also applied for admission 2019.

Attention of such candidates is invited towards Notice No. 05-BOPEE of 2019 dated 01-02-2019, wherein it has been clearly stated that the candidates who are pursuing the PG course or have left the course midway/resigned the course after cut off date shall not be eligible to compete for admission during 2019 in terms of SRO 48 of 2018 dated 30-01-2018 as such candidates are debarred from appearing for examination for three/two years as the case may be.

Whileas, the process of registration and even participation in the online counselling and admission is provisional and subject to fulfilment of all conditions as prescribed in the rules and as notified from time to time and contained in the Information Brochure also, it is reiterated that:-

- a) The candidates who are pursuing PG in any Government College in the State shall not be eligible to compete during the admission 2019 unless they have qualified the examination for the course being undertaken by him/her at present/who has appeared in the final examination but the result is awaited and is declared before the counselling process;

- b) The candidates who have been granted admission during 2017 and 2018 and joined the college but resigned after the cut off date/left the course midway shall under no circumstances be considered for admission during 2019.
- c) Concealment of facts by the candidates on the matter shall lead them to further disqualification for a period as may be decided by the Board in addition to the period prescribed in SRO 48 of 2018.
- d) Such candidates are, therefore, in their own interest advised not to participate in the further process of admission. Such candidates are also advised to inform the BOPEE about their status so that further necessary action is taken by the Board.
