In pursuance of the information contained in the e-Information Brochure MD/MS/PGD/MDS Courses, 2019 read with other Notifications/Notices on the subject, the tentative seat matrix to be operated upon during the admission process 2019 is given as per Annexure 'A' to this Notice in respect of MD/MS/PGD and as per Annexure 'B' to this Notice in respect of MDS Courses. It is further notified that:-

- a) The seat matrix so notified is tentative and subject to such changes as may become necessary in case of any updation becoming necessary due to the change in number of seats as a consequence of MCI/DCI permission/Government of India Notifications.
- b) The tentative seat matrix in respect of MD/MS/PGD has been prepared considering the conversion of diploma seats into PG Courses for some disciplines and other increases, if any, approved by the MCI.
- c) The seat matrix in respect of MDS has been prepared on the basis of the revised intake capacity of the Government Dental College, Srinagar read with SRO 154 of 2009.
- d) The seats in the ASCOM, are also added to the seat matrix. However, the fee notified in the Information Brochure for the seats in ASCOM and other Government colleges is tentative and shall be such as may be notified by the Government for the academic session, 2019. Board does not fix the fee for admission. The candidates are advised to remain in touch with the websites of the concerned colleges/institutions for this purpose. Only 11 seats in ASCOM, shall be filled in first round of counselling. 2 seats under NRI quota and 5 seats under Hindu Minority Quota (HMQ) shall be filled as per the conditions contained in the Information Brochure.
