



Subject:- Admission to MD/MS/PGD Courses, 2019 -second round of counselling (upgradation round/allotment) – schedule thereof.



Consequent upon notification of the admission list after first round of counselling and joining of the candidates upto 13th April, 2019 in pursuance of Notification No. 18-BOPEE of 2019 dated 01-04-2019 read with Notice No. 28-BOPEE of 2019 dated 08-04-2019 and Notice No. 30-BOPEE of 2019 dated 12-04-2019, and based on the shortfall as may be received from the Colleges/institutions upto 13-04-2019 (upto 5.00 P.M.) due to non joining etc., the second round of online counselling followed by subsequent rounds of counselling for filling up of the unfilled seats shall be held as per the following schedule:-

The candidates are advised to go through the Information Brochure before participating in the second round of online counselling. For facilitation of the candidates relevant portion of the counselling as notified in the e-brochure is available on the BOPEE website www.jkbopee.gov.in and attached as Annexure 'A' to this Notification. However, only such candidates shall be eligible to participate in the counselling:-

- (i) Who have joined the college/Institution during the first round of counselling.
- (ii) The candidates who did not get a seat during the first round of counselling/who did not get a seat due to choice not available in the first round of online counselling.
- (iii) Those who figure in the PSML but did not participate during the first round of counselling.

Further:-

- (i) In case the candidates are not upgraded on the basis of the fresh preferences given by them, they shall retain the seat allotted to them during the first round of counselling. However, if a candidate is upgraded as per the preferences filled in by him during the online second round of counselling, the seat allotted to him during the first online round of counselling shall be added to the seat matrix and the candidate shall have no claim whatsoever on the seat held by him prior to upgradation.
- (ii) Those who are participating for the first time in the counselling shall have to pay an online fee of Rs.2000/- through debit/credit card and e-banking.
- (iii) The candidates who have applied under NRI/Hindu Minority Quota in ASCOMS in pursuance of Notice No.25-BOPEE of 2019 dated 18-03-2019 read with Notice No. 29-BOPEE of 2019 dated 08-04-2019 shall only be eligible to compete against such seats.
- (iv) The Open Merit unfilled seats in ASCOMS, if any, shall be filled up during the second round of online counselling.
- (v) The candidates, should fill up the preferences carefully and take a conscious decision whether to participate in the online second round of counselling or not.
- (vi) The terms and conditions for mop up round shall be the same as notified in the Information Brochure.
- (vii) The Board reserves the right to notify such changes as may become necessary in view of any technical difficulty or the reasons beyond its control.
- (viii) The candidates should carefully decide about retention of the seats and resign, if they so decide, upto prescribed date, failing which they shall be debarred from participation in the admission process for three years/two years as the case may be in terms of SRO 48 of 2018 dated 30-01-2018 as leaving the seat midway or after the last date fixed for submission of resignation shall attract the provisions of the said SRO.
- (ix) The candidates should also go carefully through the conditions related to participation in the mopping up round as contained in the Information Brochure.
- (x) Board may consider filling up the seats arising due to resignation, on 6th and 7th May, 2019, to enable the Board to complete the process in a time bound manner.
- (xi) Technical instructions, if any, regarding online counselling shall also be made available on the BOPEE website www.jkbopee.gov.in in due course of time.



- (xii) The tentative seat matrix to be operated upon during the second round of counselling shall be uploaded separately and shall be available on the website www.jkbopee.gov.in. This seat matrix shall undergo such changes as may become necessary due to allotment of the seats in the upgradation process and vacation of the seats by the candidates. It shall also include the unfilled category seats having remained vacant and notified vide Notification No. 18-BOPEE of 2019 dated 01-04-2019.
- (xiii) The above schedule shall be in partial modification of the dates, if any, contrary to those notified in the Information Brochure, due to administrative and other requirements.

The above shall be subject to outcome of writ petitions, pending, if any, before any competent court of law.

1. UPGRADATION/ALLOTMENT ROUND(2ND ROUND OF COUNSELLING)

The following procedure shall be followed in case it is decided by the Board to conduct upgradation/allotment (second round) through **online** counselling:-

- (i) The candidates, who have been allotted a seat during first round and have joined the College/Institution, will be eligible to participate in the upgradation round of counselling;
- (ii) The candidates who participated in the first round of counselling but could not get a seat due to (SNA)/or CNA shall be eligible to participate in the counselling;
- (iii) The candidates eligible/desirous to participate in the upgradation/allotment round shall be required to indicate the fresh preferences for the seats proposed to be filled up (to be notified) during the said round of counselling caused due to non joining of the candidates/resignation etc;
- (iv) The preferences indicated by the candidates earlier during the first round of counselling shall, therefore, be deemed to be cancelled and shall not be applicable for this round of upgradation/allotment;
- (v) The seats vacated by the candidates during the upgradation process shall automatically be added to the seats available and allotted simultaneously on the basis of merit-cum-preference.
- (vi) The candidate applying for upgradation shall have to submit an online willingness to the effect that he/she shall participate in the upgradation round;
- (vii) **The seat allotted to a candidate in the first round, who is participating in the upgradation round shall be deemed to have been surrendered by him/her, and shall be added to the seat matrix to be filled up during second round only if he/she is upgraded and allotted a seat on the basis of upgradation. In absence of his/her upgradation, the candidate shall retain the seat allotted to him/her during the 1st round of counselling;**
- (viii) The seats left out by the OM candidate during the first round shall be allotted to the OM candidate and those left by the category candidates shall be allotted to the category candidates only during this round of counselling, provided that the seat left by the category candidate belonging to a particular category

shall be allotted to the candidate belonging to that category only from which it has become available. For example if a seat in SC category is available, it will be allotted to an SC candidate only;

- (ix) The seats additionally allowed to be filled by the MCI/Government of India, after the completion of first round of counselling and before the filling up of fresh preferences for second round of counseling shall be added to the seat matrix and filled up along with the other seats being filled up during such round.

Note:- Rule 17 shall not apply during the upgradation/allotment round. The candidates upgraded/allotted a seat shall be required to join the college within the stipulated time as may be notified by the Board.

Note:-(i)The candidates who join the college on the basis of first round of counselling and wish to participate in the second round of counselling should, therefore, take a conscious decision for participation in the second round, **as unnecessary participation in the process only causes delay in completion of the process.**

(ii)Board may, if it is expedient to do so, to display or notify the list of candidates participating in the second round of counselling along-with the seats allotted during 1st round of counselling.

SUBSEQUENT ROUND OF COUNSELLING:

The Board may, if it is expedient to do so, conduct subsequent round of online counselling/physical round of counselling in the same manner as prescribed for 2nd round of counselling provided that:-

The candidates, who did not join the college on allotment of a seat after first round of counselling or on upgradation of seat and or allotment of seat during second round shall not be eligible to participate in the subsequent round of counselling. Those candidates, who have been upgraded during the second round shall not be eligible to participate in this round, notwithstanding his/her joining the College.

2. NRI/HINDU MINORITY QUOTA:

The seats under HMQ and the NRI in the ASCOMS shall also be filled up through a process of joint physical counselling after the above process is completed. Only such

candidates shall be allowed to participate in the counselling for such seats, who fulfill the eligibility as laid down in the e-brochure and who figure in the Provisional State Merit List prepared on the basis of registration of candidates. Such candidates shall be required to produce such other additional documents as mentioned in the e-brochure or as may be further decided by the Board to ensure that only genuine and eligible candidates are considered against such seats.

3. CONVERSION OF CATEGORY SEATS IF ANY/FINAL ROUND BY PERSONAL COUNSELLING (MOPPING UP ROUND):

If otherwise required, the **Board** will issue Notification of final round by Personal Counseling on its website www.jakbopee.org and www.jkbopee.gov.in indicating schedule of selection process for final round for allotment of seats remaining vacant after completion of earlier round(s) of allotment of seats by way of Preference Forms. This final round of allotment of seats shall be conducted by way of personal counselling instead of allotment on the basis of Preference Forms to ensure that all the vacant seats are filled in before **18th May, 2019** and there will be instant seat allocation. All the candidates who have qualified the NEET 2019 but could not be allocated seats in earlier rounds and have submitted the documents in BOPEE office will be eligible to appear in the final round of counselling. Those who had not submitted the documents shall, in no case, be considered, notwithstanding their merit position. **The unfilled category seats shall also be filled up during the final round and by adding the same to the seats available.**

On account of allotment of seats in this final round of admission, no fresh vacancies consequent upon allotments made in this round will be created. This is principally because this final round of allotment is meant to fill up (as far as possible all) available vacant seats without creating a new or fresh vacant seat on account of such allotment. During this round also, eligible candidates will appear personally (**Proxy will not be permitted**), seeking allotment of seats of their choice. Personal counseling for such allotment will be held strictly in order of State Merit List number of NEET-PG/MDS, 2019. Each candidate will be offered all seats that have remained vacant and are available for allotment as per merit and preference only at time of his/her turn of counseling i.e. State Merit Position. The available seats shall be offered to the next candidate in merit.

Before personal counseling round, all available vacant seats (due to non- allotment / non-joining / resigning/ unfilled category seats to be converted to OM) will be notified on website. Eligible candidates interested to participate in this round should carefully go through vacant seats as notified on website and decide whether to participate in the Final Personal Counseling round. Such candidates, in their own interest are advised however, to

be available in the BOPEE office during the mopping up round to stake a claim on the available seats.

For the purpose of this Personal Counselling round, following seats shall be considered as available for admission which will be displayed on website before commencement of Personal Counseling round :-

- a) All seats that have remained vacant, if any, at the end of previous admission round(s) on account of non-allotment;
- b) All seats that were allotted in previous round(s) but were rendered vacant on account of candidate to whom such seats were allotted but did not join or resigned;
- c) All unfilled category seats to be converted into OM;
- d) All such seats that may become additionally available on any account whatsoever, including but not limited to seats if any additionally recognized by Medical Council of India made additionally available on account of any Order that may be passed by Courts etc.

In aforesaid final round of admission by personal counseling, preference forms submitted by all eligible candidates will not be considered and same shall be treated to have been cancelled. In other words, this final personal counseling round shall not be conducted on the basis of choices given in preference forms submitted by candidates, but on the basis of the merit-cum-preference of such candidates who are available at that time/date.

All candidates to whom seats will be allotted in accordance with choice and available seats at his/her merit position at time of personal counseling, will be required to join concerned college and complete all necessary formalities (by submitting all original documents and paying prescribe fees) for taking admission accordingly within prescribed time.

Allotment of seat once made in this personal counseling round shall not be changed. At the time of this personal counseling round, candidates must consider available seats thoroughly and opt for a seat which they must join once allotted.

It is made hereby clear that in case such a candidate does not join concerned College and/or fails to comply with necessary formalities, his/her admission shall be cancelled.
