## **Notification No:- 28-BOPEE of 2019**

**Dated: 30-4-2019**

Consequent upon completion of (three days) 2nd round of upgradation/ allotment round of counselling for MD/MS/PG diploma held w.e.f 19<sup>th</sup> of April to 21<sup>st</sup> April, 2019 and in pursuance of notification No. 21-BOPEE of 2019 dated 12-04-2019, the mopping-up round for unfilled seats due to non-joining etc. and resignation as may be submitted up to 4<sup>th</sup> of May, 2019, shall be held in the Board office simultaneously at Jammu and Srinagar on **6<sup>th</sup> and 7<sup>th</sup> of May, 2019.**

It is further notified that:-

1. The eligible and willing candidates have to report in the BOPEE office at 8:30 AM upto 10:00 AM for registration and fulfilment of all formalities, as otherwise required and notified from time to time, before they are allowed to participate in the counselling process;
2. The candidates who have not been allotted any seat during the 1<sup>st</sup> / 2<sup>nd</sup> round of counselling shall be eligible to participate in the mopping-up round in terms of conditions contained in the Information Brochure, details whereof are also annexed herewith **as Annexure "A"** to this notification;
3. The Board has also decided to allow such candidates to participate in the counselling process, who have been allotted a seat during 1<sup>st</sup> round of counselling and have joined the college but have not been upgraded during the 2<sup>nd</sup> round and those who have been allotted seat during the 2<sup>nd</sup> round of counselling and have joined the college/institution and wish to participate in the mopping-up round for purpose of upgradation. However, any candidate upgraded during the 2<sup>nd</sup> round shall under no circumstances be allowed to participate in the mopping-up round.

4. The candidates allotted seats during the mopping-up round shall have to necessarily join the college/institution upto **12<sup>th</sup> May, 2019** and shall not be allowed to resign. However, such candidate, who do not join the college upto to the prescribed date or resign subsequently, will attract the provisions of SRO 48 of 2018 dated 30-01-2018 and shall be debarred for 3/2 years as laid down in the said SRO as also reiterated by the Board from time to time . The candidates should, therefore, take a conscious decision about participation in the mopping-up round for allotment of a seat;
5. The candidate should go through all relevant Notifications including Notification No. 21-BOPEE of 2019 dated 12-04-2019 and Notification No. 24-BOPEE of 2019 dated 19-4-2019, Notification No. 26-BOPEE of 2019 dated 20-4-2019 and Notification No. 27-BOPEE of 2019 dated 21-04-2019 along with the e-Brochure notified by the Board with particular reference to the mopping-up round of counselling;
6. The tentative seat matrix as on 30<sup>th</sup> of April, 2019 is annexed herewith as **Annexure "B"** to this Notification. This includes the seats already notified vide Notification No. 27-BOPEE of 2019 dated 21-04-2019 and those which have been reported as unfilled by the college/ institutions and those who have resigned upto 30<sup>th</sup> of April, 2019. However, since the candidates who have joined the institutions have been given opportunity to resign upto 4<sup>th</sup> of May, 2019 in pursuance of Notification No. 21-BOPEE of 2019 dated 12-04-2019, therefore, the updated tentative seat matrix shall be uploaded on the BOPEE website on 4<sup>th</sup> of May, 2019 (5:00 PM).

The **Annexures "A" and "B"** shall be available on the BOPEE website i.e [jkbopee.gov.in/](http://jkbopee.gov.in/) [jakbopee.org](http://jakbopee.org) only. The candidates are also advised to remain in touch with the BOPEE websites for updates if any.

**Note:-**

The candidates, who are eligible and willing are in their own interest are advised to participate in the mopping-up round on 6<sup>th</sup> of May, 2019. Counselling will also be held on 7<sup>th</sup> of May, 2019, in case any seat remains un- filled on 6<sup>th</sup> of May, 2019, which shall be carried forward to 7<sup>th</sup> of May, 2019 and notified accordingly.

## 1. CONVERSION OF CATEGORY SEATS IF ANY/FINAL ROUND BY PERSONAL COUNSELLING (MOPPING UP ROUND):

If otherwise required, the **Board** will issue Notification of final round by Personal Counseling on its website [www.jakbopee.org](http://www.jakbopee.org) and [www.jkbopee.gov.in](http://www.jkbopee.gov.in) indicating schedule of selection process for final round for allotment of seats remaining vacant after completion of earlier round(s) of allotment of seats by way of Preference Forms. This final round of allotment of seats shall be conducted by way of personal counselling instead of allotment on the basis of Preference Forms to ensure that all the vacant seats are filled in before **18<sup>th</sup> May, 2019** and there will be instant seat allocation. All the candidates who have qualified the NEET 2019 but could not be allocated seats in earlier rounds and have submitted the documents in BOPEE office will be eligible to appear in the final round of counselling. Those who had not submitted the documents shall, in no case, be considered, notwithstanding their merit position. **The unfilled category seats shall also be filled up during the final round and by adding the same to the seats available.**

On account of allotment of seats in this final round of admission, no fresh vacancies consequent upon allotments made in this round will be created. This is principally because this final round of allotment is meant to fill up (as far as possible all) available vacant seats without creating a new or fresh vacant seat on account of such allotment. During this round also, eligible candidates will appear personally (**Proxy will not be permitted**), seeking allotment of seats of their choice. Personal counseling for such allotment will be held strictly in order of State Merit List number of NEET-PG/MDS, 2019. Each candidate will be offered all seats that have remained vacant and are available for allotment as per merit and preference only at time of his/her turn of counseling i.e. State Merit Position. The available seats shall be offered to the next candidate in merit.

Before personal counseling round, all available vacant seats (due to non- allotment / non-joining / resigning/ unfilled category seats to be converted to OM) will be notified on website. Eligible candidates interested to participate in this round should carefully go through vacant seats as notified on website and decide whether to participate in the Final Personal Counseling round. Such candidates, in their own interest are advised however, to be available in the BOPEE office during the mopping up round to stake a claim on the available seats.

For the purpose of this Personal Counselling round, following seats shall be considered as available for admission which will be displayed on website before commencement of Personal Counseling round :-

- a) All seats that have remained vacant, if any, at the end of previous admission round(s) on

account of non-allotment;

- b) All seats that were allotted in previous round(s) but were rendered vacant on account of candidate to whom such seats were allotted but did not join or resigned;
- c) All unfilled category seats to be converted into OM;
- d) All such seats that may become additionally available on any account whatsoever, including but not limited to seats if any additionally recognized by Medical Council of India made additionally available on account of any Order that may be passed by Courts etc.

In aforesaid final round of admission by personal counseling, preference forms submitted by all eligible candidates will not be considered and same shall be treated to have been cancelled. In other words, this final personal counseling round shall not be conducted on the basis of choices given in preference forms submitted by candidates, but on the basis of the merit-cum-preference of such candidates who are available at that time/date.

All candidates to whom seats will be allotted in accordance with choice and available seats at his/her merit position at time of personal counseling, will be required to join concerned college and complete all necessary formalities (by submitting all original documents and paying prescribe fees) for taking admission accordingly within prescribed time.

Allotment of seat once made in this personal counseling round shall not be changed. At the time of this personal counseling round, candidates must consider available seats thoroughly and opt for a seat which they must join once allotted.

It is made hereby clear that in case such a candidate does not join concerned College and/or fails to comply with necessary formalities, his/her admission shall be cancelled.
