In amplification of Notification No. No. 30-BOPEE of 2019 Dated 7-05-2019, It is clarified that:-

1. One seat under NRI category in Anaesthesiology in ASCOMS has remained unfilled during the Mop up round of counselling held on 6<sup>th</sup> and 7<sup>th</sup> May 2019. In case of non-availability of NRI candidates, the seat shall be treated as open and filled up from OM candidates subject to the condition that the fee of NRI seat would remain equal to the NRI fee but foreign currency would not be required and such candidates who opt for NRI seat which has been made open shall not be requiring any documentation for NRI category.
2. The candidates, who are willing to be considered against the above unfilled seat may register themselves with the BOPEE office at Srinagar/Jammu up to 10<sup>th</sup> May 2019 so that in case of non-availability of NRI candidates the seat is treated open and filled up accordingly.
