**Public Notice No: 41 - BOPEE of 2019**

The NEET- UG 2019 has been conducted by the National Testing Agency (NTA) on 5<sup>th</sup>, May, 2019 and the result will be declared tentatively by 6th June, 2019. The Ministry of Home and Ministry of Health and Family Welfare, Government of India have been allocating MBBS/BDS seats to J&K State for nomination of the candidates for their admission outside the state in different Medical/Dental Colleges of the country in terms of the Guidelines issued by the respective Ministries. It is for the information of those candidates, who wish to compete under **Central Pool** MBBS/BDS quota for the year 2019-20 that the guidelines of the respective ministries and the necessary documents required to be furnished by the prospective eligible candidates are given in Annexure "A" to this Notice.

All the intending candidates, who will qualify NEET undergraduate MBBS Course conducted by National Testing Agency (NTA), 2019 and wish to apply for MBBS/BDS course under Central Pool are informed in advance that they should, in their own interest, keep the documents mentioned in Annexure "A" ready so that they do not face any difficulty in applying as and when the seats, if any, are allocated to the state of J&K by the concerned Ministries under the Central Pool Quota. They are further informed that mere preparation of documents will not confer any right on the candidates to stake a claim and the candidates will be considered only, subject to their eligibility, as and when the seats are notified by the respective Ministries to the State of J&K, which are usually notified to the state governments during the month of July/August and the admission are to be completed as per the schedule as laid down by the Ministry of Home and Health and Family Welfare, Government of India or any other competent authority.

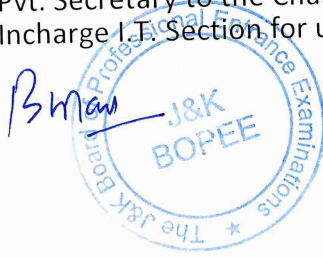
