Consequent upon the completion of the first round of counselling, availability of unfilled seats and the shortfall as may be received from the colleges, the second round of counselling for filling up of the unfilled seats in different colleges/institutions of Polytechnic shall be held physically in the Board Offices at Srinagar/Jammu w.e.f. **27-06-2019 to 02-07-2019** as per the following schedule:-

The candidates up to the score of 5 marks in the PET Entrance Test shall be eligible to participate in the physical round of counselling.

In view of large number of seats having remained vacant after the first round of counselling, it has been decided to allow those candidates also to participate in this physical round of counselling, who were allotted a seat during the first round of online counselling but could not join the allotted college/institute because of one or the other reason.

The candidates shall have to register in the Board office between 8.00 a.m. to 10.00 a.m. on every day of counselling schedule mentioned above.



The candidates, who have not paid the online fee shall have to deposit the counselling fee of **Rs.500/-** in the BOPEE Office through POS machines for being eligible to participate in the counselling.

The candidates, whose result was with held and could not participate in the online first round of counselling but have completed the deficiencies now shall also be eligible to participate. However, they shall have to produce the deficient document(s) during the time of counselling. The candidates are further required to produce a proof of identity while participating in the counselling process.

- 1) The tentative seat matrix shall be available on the official website of the BOPEE, which shall be updated after the shortfall from the Colleges is received.
- 2) The candidates who have joined the college and want to participate in the second round of counselling shall produce the receipt of the fee deposited in the College, during registration/counselling.
- 3) The other terms and conditions shall remain the same as notified in the Notification No. 45-BOPEE of 2019 dated 07-06-2019.
