are also available and shall be filled up during second round of counselling as also notified earlier.

The allotment/ upgradation of seats against the unfilled seats shall accordingly take place w.e.f. 18-07-2019 to 20-07-2019 as per the following schedule:-

Those who registered up to 17-7-2019 in pursuance of Notification No. 61-BOPEE of 2019 dated 08-07-2019 can participate, on the date on which their score falls in counselling. Board may notify the list of such candidates also on 17-7-2019 for facilitation of the candidate which can be checked from BOPEE website www.jkbopee.gov.in.

It is again notified that the candidates:-

- i) allotted Government/Private Colleges in the first round of online counselling but who have not joined because of one or the other reason shall be given an opportunity to compete against the Government seats on the basis of merit cum preference;
- ii) who were allotted seats in ASCOMS, but did not join, will ordinarily not be considered for re-allotment in the said College unless they produce requisite documents in support of their ability to meet the financial requirements of the College as it has been noticed that many candidates have failed to take admission in view of their inability to pay the fee etc;
- who figure in the PSML but have not participated in the first round of online counselling shall be eligible to participate in the physical round of counselling;
- iv) who did not get a seat during online round of counselling shall also be eligible to participate in the counselling:
- v) desirous of participating in the counselling process shall report in the BOPEE Office, Jammu/Srinagar for registration on their respective date of counselling between 8.00 a.m to 10.00 a.m. to be eligible to participate in counselling on their turn/rank;
- vi) participating for the first time shall have to deposit a fee of Rs.1500/- through POS machines available in BOPEE Offices before they are allowed to participate in the counselling;
- vii) shall have to submit fresh preferences on their respective date of counselling;
- viii) are advised to go through the Information Brochure available on BOPEE website www.jkbopee.gov.in. Other conditions mentioned there but not mentioned above shall apply.

Note:-

(1) Board reserves the right to notify the list on day to day basis or on completion of the second round of counselling as may be deemed fit by the Board. The seat allotted

on a particular day on the basis of merit and preference of the candidates cannot be altered in case a higher merit candidate fails to appear in the counselling at his rank, time/date. However, he can appear subsequently to compete for seats available at that time. Candidates will get limited time to join the college after completion of the second round.

- (2) Any category seat remaining unfilled shall be treated as OM and filled up by the Board as per the schedule as may be notified
- (3) The candidates should weigh their options of allotment of seat carefully before formally approaching the Board for participation in the second round of counselling with a view to avoid un-necessary rush of candidates during the process of counselling. Since the rank has been notified earlier and the availability of seats is now notified in advance, therefore, the candidates can better visualize the prospect of allotment of seat.
