**Subject:- Online registration for AYUSH and CRC and BPT Courses, 2019 – clarification thereof.**


Notice No. 73-BOPEE of 2019

In amplification of Notification No. 66-BOPEE of 2019 19-7-2019 read with Notification No. 70-BOPEE of 2019 dated 23-07-2019 and Notice No. 72-BOPEE of 2019 dated 18-07-2019 it is hereby clarified that:-

1. The candidates who have already registered for NEET UG (MBBS/BDS) and want to update their category status for the purpose of Ayush/BPT courses may deposit self attested copies of valid category certificate in the BOPEE office at Srinagar/Jammu along with the original certificate for verification purpose so that the same are updated in the records of the candidates in due course of time.
2. The cutoff date for issuance of certificate shall be the last date of filling up of online registration viz 31-7-2019.
3. No under process certificate shall be accepted under any circumstances.
4. The candidates who were deficient of documents at the time of NEET UG registration (MBBS/BDS) shall also be required to approach the BOPEE office to deposit the documents in case the same are not accepted online due to systematic limitations. Similarly the candidates whose registration was incomplete at the time of NEET UG (MBBS/BDS) registration may also deposit the documents in the BOPEE office Srinagar/Jammu, in the similar manner as at one above along with original documents for verification so that the application form is completed by the Board, as the system may not accept such updations by the candidates.
