In pursuance of Notification No. 66-BOPEE of 2019 dated 19-07-2019 read with other Notices on the subject, the list of candidates, who have registered online for consideration for counselling of AYUSH/BPT Courses based on the NEET rank/score as per Annexure 'A' to this Notification is hereby notified for the information of the candidates. These candidates shall figure appropriately in the State Merit List notified vide Notification No. 54-BOPEE of 2019 dated 25-06-2019 (NEET-UG State Merit List) as per their NEET rank/score. The list so updated shall accordingly be utilized for purpose of counseling of candidates for filling up of the seats in AYUSH/BPT Courses.

The candidates whose documents are deficient/incomplete should approach the BOPEE Office along with such documents so that their cases are considered on merits and allowed to participate in the counseling only after submission of the deficient documents. Such candidates have also been shown in Annexure "A" but mere figuring in the Annexure should not entitle them to participate in counselling unless they clear the deficiencies and are permitted by the Board

Consequent upon the above, it is further notified that:-

(i) Online counselling for filling up seats under AYUSH/BPT Courses, 2019 will start w.e.f. 3-8-2019 to 14-8-2019 (2.00 p.m).

IMPORTANT

- Commencement of online counselling w.e.f. 3-8-2019 to 14-8-2019.
- 2. Pay online fees of Rs 1500/- (Those who have not made payment earlier during NEET Counselling)
- 3. Last date of payment of fee 14-8-2019 (mid night);
- 4. Reservation shall be applicable in Government Ayurveda College, Jammu;
- 5. The cut off score for Open Merit candidates is 134 and for reserved category candidates other than JKPM/CDP/Sports category candidates is 107.

- (ii) The candidates are advised in their own interest to go through the instructions contained in the e-Brochure for submitting the online preference forms. The candidates after locking the preferences/making the payment cannot modify the preferences unless they approach the Board Offices at Srinagar/Jammu and are permitted to do so by the Board. Time for deposition of the online fee of Rs.1500/shall be upto 14-8-2019 midnight after which no fee shall be accepted by the system. The fee can be paid online through credit card, debit card/e-banking, etc;
- (iii) As of now no admission is being made in Jammu Institute of Ayurveda & Research, Jammu in light of Ministry of AYUSH Order No. F.No. 2-14014/65/2019-E-P(1) dated 04-07-2019, wherein admissions in the said college for 2019-20 have not been approved/authorized.
- (iv) The tentative seat matrix is available on the BOPEE website www.jkbopee.gov.in which is however, subject to changes depending upon the decision of the Board and shall form Annexure 'B' to this Notification.
- (v) In pursuance of Government Order No. 634-HME of 2019 dated 04-07-2019 issued by the Health & Medical Education Department, J&K the seats under Management Quota in Private Colleges under AYUSH (BAMS/BUMS) shall be filled during the online counselling. However, the seats under Management Quota in College of Physiotherapy shall be filled during second round of counselling
- (vi) The seats under P&B category in private colleges shall not be filled up during the first round of counseling, therefore, candidates belonging to P&B category shall be considered along with other candidates during this round of counseling. The P&B seats shall, however, be filled up during the 2nd round of counseling or as per the schedule as may be notified by the Board.
- (vii) The conditions not mentioned hereinabove but otherwise notified by the Board through various Notifications/Notices on the subject will be applicable to the counseling/admission process.
- (viii) The seats under BPT in CRC, Bemina are not being filled during this round of counselling as they have failed to provide detailed information.

Since the candidates from the State Merit List notified vide Annexure "A" to this Notification are also eligible along with those notified vide Notice No. 54-BOPEE of 2019 dated 25-06-2019, therefore, the NEET rank will determine the inter-se rank of the candidates. The technical instructions for filling up the online preference forming Annexure "C" to this notification shall be available on the BOPEE website www.ikbopee.gov.in only.

The other instructions on the subject shall be available on the BOPEE website as Annexure "D". The candidates are advised to remain in touch with the BOPEE website www.jkbopee.gov.in for further information/updates

- 3. The seats under Poor and Backward (P&B) category and seats sanctioned under Management quota in Institute of Asian Medical Sciences, Kashmir Tibbia College and Jammu college of Physiotherapy Jammu shall be filled in separately after filling up of open merit seats of these colleges.



Instructions for submitting online Preference Form

- Candidates are advised, in their own interest, to go through the Instructions contained therein before actually submitting the online Preference Form.
- BOPEE is seeking Preferences from such candidates who have qualified for NEET UG, 2019 and have been asked to fill in the Preference Form online only
- The online Preference Form enables a candidate to fill in the preferences for various disciplines/institutions for allotment of a seat for admission in Ayush/BPT courses, 2019 in Government Institutions/ Private College as the case may be.
- Candidates need to login into the application using the same username and password which was used while filling up of registration form.
- During the online filling up of Preference Form, the candidates will get all the details of the courses available viz-a-viz the institutions.
- Candidate should select his/her most preferred preference first along with the College of preference followed by second, third, fourth and so on for the said course.
- The second preference for the course shall be given by the candidate by choosing the college preference as above.
- 8. This preference shall be available till all the preferences/ colleges are exhausted by the candidate
- Candidate will be required to fill up at least one preference for a course/college and without entering any preference the candidate will not be able to proceed further
- 10. Candidates can modify the preferences selected by them till such time they do not finally submit/lock the Preference Form, after which the candidate will not be able to modify the same
- 11. The candidate shall have to deposit a Fee of Rs. 1500 online and after locking the preferences. However those candidates who have deposited their fee during NEET UG MBBS/BDS 2019 counseling need not to pay online fee again.
- 12. Candidates will get sufficient time to fill in the Preference Form and should not be in a hurry while filling up the Form. This system has been evolved to facilitate candidates to fill in the form online without approaching the BOPEE office in person.

- 13. Candidates who have submitted the form online shall, however, be required to download/print at least one copy of the Preference Form for retention by the candidate.
- 14. Candidates should remain in touch with the BOPEE website for update, if any, in this regard
- 15. For further information please see the Technical information as under:

1. Please read the instructions carefully.

2. Submitting Preferences:

- a. Candidate must lock the preferences before the last date; candidates will not be able to lock their choices after the last date.
- b. Click on "Subject" link after logging in.
- c. Select course candidate wants to apply and then click on "Select" button.
- d. Selected course available in the college will be shown in the "disciplines available box"
- e. Candidates are advised to select course as per their preferences from "disciplines available box" and clicking on ">>" button to set their preferences, course chosen will be shown in the "disciplines assigned box" with preference selected.
- f. If a candidate wants to remove the preference he/she can do so by selecting the preference from "disciplines assigned box" and clicking on "<<" button.</p>
- g. Preferences select by the candidate will be saved automatically; candidate will get the operations performed by him/her whenever he/she logs in to the Application.
- h. Candidate can also see the preview of the preferences selected by him/her by clicking on "Preview" button and can also take the print out of the same for their perusal.
- Candidate can add and delete preferences anytime but before last date and before locking their preferences.
- j. If candidate wants to lock his/her choices, click on "Submit" button; a preview of choices will be shown and if he/she is satisfied with his/her preferences locked him/her then by clicking on "Submit" button the Preview Page of selected choices will be locked.
- k. Once a candidate locks his choices then no modification can be done in the preferences selected.

- Candidates will be given the option to "make payment" of fee online only after the choices are locked, Fee must be paid before the last date of fee submission.
- m. Candidates can submit fee after locking their choices and clicking on subject tab.
- n. Only those Applications will be accepted having choices locked and have fee submitted on time, Applications failing this criteria will be rejected.

3. Making Fee Payment:

- a. Fee will only be paid online before the last date of fee submission.
- b. Fee payment option will be given only after candidate locks his/her preferences.
- c. Click on "make payment" button, candidate will be redirected to Payment Page and make payment by choosing any available option.
- d. Payment Receipt will be generated after payment is successful.
- e. Candidate can take print out of the payment receipt.

4. Password forgotten:

- a. Candidate can reset password of their account by going to login page clicking on "Forget Password" link, after entering Roll NO. and Date of Birth and Email will be sent to the email ID of the candidate
- b. Click on the link in the mail, candidate can now set new password.

Other Instructions

- A. That they are advised in their own interest to go through the instructions contained in the e-Brochure for submitting the online preference forms. However, summary of the instructions is as under:-
- B. The online preference forms can be filled in by going to the BOPEE website (www.jkbopee.gov.in) in this regard, by following the procedures and processes as contained in the Brochure. For facilitation of the candidates the technical and other instructions for online counselling are annexed with this Notification as Annexure 'C' which shall be available on the BOPEE website only. In case of any difficulty they can contact the officials of the BOPEE at the below mentioned numbers or can approach the BOPEE office in person for facilitation. They can also avail the facility of filling up the online preference forms from the National Informatics Centres at District Headquarters or from any Khidmat Centre on payment of charges as notified by the Government from time to time:-
- C. The candidate should select his/her most preferred preference first along with the college of preference followed by 2nd, 3rd, 4th and so on and so forth;
- D. At least one preference shall be required to be filled by the candidate;
- E. Further for any clarification also the candidate can approach the Board Office/above contact numbers;
- F. The candidates who have not deposited the fee earlier at the time of NEETUG, MBBS/BDS counseling shall have to deposit an online fee of Rs.1500/-through credit card/debit card/e-banking before submitting the preferences. The candidates, who do not make the online fee shall not be eligible for further consideration;
- G. The candidates as indicated in Notification No. 54-BOPEE of 2019 dated 25-06-2019, whose documents are deficient shall in no case be eligible for filling up of the online preference forms except in terms of the conditions of the said Notification/Notice, as they shall be required to submit the deficient documents in person in the Board Office at Jammu/Srinagar before their request for allowing them to participate in counseling is considered. Besides such candidates, if any, who do not fall in the cut off merit for OM and reserved categories shall also not be eligible for online counselling/filling up of preferences forms;
- H. Mere filling up of the online preference by the candidates shall not confer any right upon him/her to be considered for seat allotment in the Government/Private AYUSH/BPT Colleges, which shall and shall be determined on the basis of his/her actual eligibility in accordance with the rules and procedures as notified from time to time read with information contained in the Information Brochure, 2019. The admission against the seats shall be made strictly on the basis of merit-cum-preference read with J&K reservation rules in the Government College of Ayurveda, Jammu and other rules on the subject as notified from time to time;

- During these processes, the candidates can amend the preferences as many times as they wish as the purpose is only to facilitate the candidates with the procedures. They can upload all the preferences and fill up the same repeatedly. This will be a practical session.
- J. Since the Board follows common counseling for Government/Private Colleges/Institutions for BAMS/BUMS/BPT Courses, therefore, the candidates should indicate the choice/preference accordingly for Government/Private Colleges/Courses; and

K. The candidate shall be personally responsible for filling in of any wrong information and Board shall have no liability on this account.
