Consequent upon receipt of shortfall from Government College of Education, Jammu vide their letter No. GCOE/J/2019/909-11 dated 21-08-2019 after the last date of joining of candidates pursuant to Notification No 79-BOPEE of 2019 dated 03-08-2019 and Notice No. 77-BOPEE of 2019 dated 20-08-2019, the candidates as indicated in this Notification, have been provisionally selected for admission to B.Ed. Course- 2019 in **Government College of Education, Jammu** against the said shortfall. The Principal of the College will get the following certificates in original verified from the Incharge admission and countersigned by him/her before allowing the candidates to complete their admission formalities:-

This is subject to having passed B.A/B.Sc./B.Com/BCA/BBA or its equivalent examination from a recognized University/Institution according to 10+2+3 pattern with not less than 50% of marks in aggregate in the qualifying examination in case of Open Merit candidates and 40% of marks in aggregate in case of Reserved Category Candidates.

The candidates shall report the **Government College of Education, Jammu** upto **2nd of September, 2019 (4:00 P.M.)** along with their relevant Certificates in **Original** and the

Electronic Admit Card downloaded by them from the official website(s) of BOPEE. The Head of the Institution shall send within the prescribed last date the Roll Nos., Rank and Names of the candidates, who fail to complete their admission formalities or who may be otherwise ineligible for having failed to pass the qualifying examination with the requisite percentage as **SHORT FALL** on 02nd of **September, 2019** upto 5.00 P.M. to the BOPEE office, Srinagar/Jammu positively.

NOTE:

1. The Application Forms for admission to B. Ed. courses were invited from the aspiring candidates including those, whose result of qualifying examination was awaited. Thus, mere enlisting of any candidate in the annexed list will not confer any right upon him/her to claim admission, if otherwise found ineligible.
2. The details of candidates found ineligible, if any, shall be submitted by the college to the Board along with the shortfall.
3. The candidates with rank 138 (RBA) who was selected in their respective category vide Notification No. 060 of BOPEE Dated 07-07-2019 are now/hereby treated to have been selected in Open Merit.
4. The Board has received representation from one candidate bearing rank 0674 that she could not join the college on the basis of selection during 2nd round of allotment vide Notification No. 067-BOPEE of 2019 dated 22-07-2019. Having considered this representation, candidate has been included in the current list, on the basis of her merit.
5. The candidates, who have failed to deposit their deficient Documents/Certificates till date, if any, have not been considered for admission in the selection process.
