## Notice No.82-BOPEE of 2019 Dated 29-08-2019

Vide Public Notice No. 41-BOPEE of 2019 dated 08-05-2019 Board had in advance notified for the information of eligible and willing candidates who wish to compete under Central pool MBBS/BDS quota seats for the year 2019-20 the guidelines of the respective ministries and the necessary documents required to be furnished by the candidates. Now the Ministry of Health & Family Welfare vide their communication No. U.14014/4/2019-ME-II dated 16<sup>th</sup> August, 2019, received by the BOPEE on 29-08-2019 through Health & Medical Education Department vide their Letter No. ME/Gaz/93/2019 dated 29-08-2019 has notified four seats allotted to Jammu and Kashniir from central pool for MBBS, 2019-20 in the following colleges:-

1.	Nalanda Medical College, Patna, Bihar =1
2.	Govt. Medical College, Chandigarh =1
3.	Lady Hardinge Medical College, New Delhi = 1
4.	SMS Medical College, Jaipur, Rajashan =1

The last date for submission of documents complete in all respects/reporting in the colleges etc. has been fixed as **31-08-2019**. However, despite limited time available at the disposal of the Board and in furtherance of the communication dated 29-08-2019 from the Health and Medical Education Department, Government of Jarnmu and Kashmir, it has been decided to invite applications on plain paper from the eligible candidates on their own risk and responsibility, which shall be forwarded to the concerned quarters for further necessary action as may be deemed appropriate. Willing and eligible candidates can obtain the full details from the BOPEE Office, Jammu/Srinagar during office hours upto 3<sup>rd</sup> September, 2019. The brief of the guidelines is as under:-
